Kotri' where under performing is due to the fault of the contractor supplier or consultant.'

And sub rule 35-3(C) 'contractor & Consultant or supplier may be Black Listed if he fails to take the specified remedial actions Within a specified time period' therefore M/s. Haji Badruddin & Haji Shamsuddin is hereby Black listed by this office.
