Subject: - **BLACK LISTING OF FIRM.**

The Seventeen Purchase Orders were placed as per PPRA rules on M/S, Uqba Traders Rawalpindi. The firm was issued several notices/reminders for supply of material but the firm failed to do so. Firm's this act caused loss to Pakistan Railways due to non supply/availability of material.

Due to non co-operation and deliberately failing to supply the material urgently required and successive Purchase Orders were cancelled with forfeiture of 5% security money.

Owing to the violation of contractual obligations, it has been decided (as per Pakistan Railways Blacklisting Policy para 5.3) without any prejudice to blacklist the firm M/S, Uqba Traders Opp, Garden College Office No.1, Liberty Plaza Rawalpindi along with Proprietor Muhammad Ayub Sales Tax/NTN No.34002792688-19/2792688-5 for doing business with Pakistan Railways as such no tender enquiry and purchase orders will be issued to said firm however they will complete all outstanding purchase orders already placed on them accordingly.
