I am directed to enclose herewith a self explanatory copy of letter received from M/S Mediurge Pvt, Ltd a firm of Medical Equipment, vide No. MU1909314-M dated 20th September 2019, wherein they are requesting to withdraw order of black listing which was issued vide this department's order of even No dated 13-09-2019, copy of same was endorsed to SPPRA among others (Copy attached).

In fact Contracts for supply of Medical Gases System for DHQ Hospitals Khairpur, Shikarpur, Badin and O.T Tables for DHQ Hospitals Naushehroferoz, Sanghar, Tando Muhammad Khan, Tando Allahyar & Kotri, were awarded to M/S Mediurge Pvt Ltd, 77-Sector A-1 Township, Lahore 54770, being lowest evaluated bidder, by the Project Director, Defunct Project Rehabilitation of DHQ/THQ Hospitals in Sindh, vide orders No. PD/DHQ/2241, PD/DHQ/2237, PD/DHQ/2242, D/DHQ/2239, PD/DHQ/2238, PD/DHQ/2236, PD/DHQ/2235, PD/DHQ/2240 dated 7-06-2016 respectively. As per work orders schedule of delivery was 90 days i.e upto 4th September 2016, but despite issuance of several reminders and show cause Notices by the Project Director of Defunct Project of Rehabilitation of DHQ/THQ Hospitals in Sindh the said firm was failed to supply these items. After lapse of one year i.e 31st August 2017, M/S Mediurge Pvt ltd supplied only O.T Tables, whereas rest of order viz Centralized Medical Gases Supply systems for DHQ Hospital Khairpur, Shikarpur and Badin has not been completed so far, even the vendor has accepted his negligence in the above said letter that final installation of Air Compressor (main part of Medical Gases Supply System) is in process, whereas same are not received to end users so far. Further he is stating in his above said letter that he will take 8 weeks more to complete installations.

Moreover M/S Mediurge submitted 2 CDRs No. 0166567 amounting to Rs. 8,043,623/= & No. 0166568 Rs. 2,506,661/=, in favour of Project Director, Defunct Project Rehabilitation of DHQ/THQ Hospitals in Sindh against 20% remaining amount of the orders, issued from Bank of Punjab, IBKM Ferozpur Branch Lahore were found fake and these were not issued by the said branch as informed by the concerned Branch Manager vide his letter No. Nil dated 2nd May 2019. (Copy attached)

In this connection opportunity was given to M/S Mediurge Pvt ltd through show cause Notice of even number dated 14th June 2019 and subsequently Final Show cause of even number dated 10th July 2019 to clarify his position (Copies attached), but he failed to justify his position, therefore keeping in view above facts Competent Authority black listed M/S Mediurge Pvt ltd, under **SPPRA Rule 35 (b) Involvement in corrupt and fraudulent practices while obtaining or attempting to obtain a procurement contract ; (d) willful failure to perform in accordance with the terms of one or more than one contract;** vide this department's order of even No dated 13-09-2019 copy of same was endorsed to SPPRA among others (Copy attached).

Keeping in view above request/appeal of M/S Mediurge Pvt ltd and preceding facts, guidance of SPPRA as per SPPRA rule 35(4) is solicited.





PD/DHQ/1912, 1914, for purchase of Centralized Medical Gases Supply systems and O.T Tables for DHQ Hospitals Khairpur and Badin whereas work orders for supply of O.T Tables for DHQ Hospitals Shikarpur, Naushehro Feroz, Sanghar, Tando Muhammed Khan, Jamshoro @ Kotri, Tando Allahyar, vide Nos. PD/DHQ/2235, 2236, 2238, 2239, 2240, dated 27th May 2016 were issued to your firm. As per work order delivery time of all these items was 90 days. Despite issuance of several reminders and show cause Notice by the Project Director of Defunct Project of Rehabilitation of DHQ/THQ Hospitals in Sindh you were failed to supply these items within stipulated delivery time. DHQ Hospital Badin: Complete system has been installed and in operation since last year. Only compressor need to be installed.

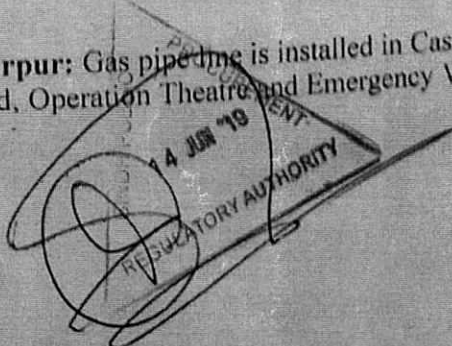
DHQ Hospital Shikarpur: All items have been supplied and installed except compressor

DHQ Hospital Khairpur: All equipment have been supplied and work is under process and we are expecting to complete this task within next 6 weeks time sure.

In view of your above said letter, Medical Superintendents Khairpur, Shikarpur and Executive Director Indus Hospital (DHQ Hospital Badin) were asked to submit their views, which as under:

DHQ Hospital Badin: Compressor Room is ready and all works associated with Centralized Medical Gases System are completed by the Management of Idus Hospital/ DHQ Hospital Badin, whereas M/S Mediurge did not complete the supplies and installation of Air Compressor, Pipelines, filters and humidifiers etc.

DHQ Hospital Shikarpur: Gas pipeline is installed in Casualty Department, Medical Ward, Male / Female surgical ward, Operation Theatre and Emergency Ward, remaining equipment not supplied by Mediurge pvt ltd.

SUBJECT: Blacklisting of M/S Mediurge Pvt Ltd.

Whereas the contract of supply of Medical Gases System for DHQ Hospitals Khairpur, Shikarpur, Badin and O.T Tables for DHQ Hospitals Naushehroferoz, Sanghar, Tando Muhammad Khan, Tando Allahyar & Kotri, was awarded to M/S Mediurge Pvt Ltd, 77-Sector A-1 Township, Lahore 54770 being lowest evaluated bidder, by the Project Director, Defunct Project Rehabilitation of DHQ/THQ Hospitals in Sindh, vide orders No. PD/DHQ/2241, PD/DHQ/2237, PD/DHQ/2242, D/DHQ/2239, PD/DHQ/2238, PD/DHQ/2236, PD/DHQ/2235, PD/DHQ/2240 dated 7-06-2016 respectively. As per work orders schedule of delivery was 90 days i.e upto 4th September 2016. But despite issuance of several reminders and show cause Notice by the Project Director of Defunct Project of Rehabilitation of DHQ/THQ Hospitals in Sindh the said firm was failed to supply these items. After lapse of one year i.e 31st August 2017, M/S Mediurge Pvt Ltd supplied only O.T Tables, whereas rest of supply i.e Centralized Medical Gases Supply systems for DHQ Hospital Khairpur, Shikarpur and Badin has not been supplied/installed so far.

Whereas M/S Mediurge submitted 2 CDRs No. 0166567 amounting to Rs. 8,043,623 & No. 0166567 Rs. 2,506,661/=, in favour of Project Director, Defunct Project Rehabilitation of DHQ/THQ Hospitals in Sindh, issued from Bank of Punjab, IBKM Ferozpur Branch Lahore were found fake and these were not issued by the said branch as informed by the concerned Branch Manager vide his letter No. Nil dated 2nd May 2019.

Whereas opportunity was granted to M/S Mediurge Pvt Ltd through show cause Notice of even number dated 14th June 2019 and subsequently Final Show cause of even number dated 10th July 2019 to clarify his position, but he failed to justify his position properly. Now therefore keeping in view above facts Competent Authority has black listed M/S Mediurge Pvt Ltd, 77-Sector A-1 Township, Lahore 54770 under SPPRA Rule 35 (b) Involvement in corrupt and fraudulent practices while obtaining or attempting to obtain a procurement contract; (d) willful failure to perform in accordance with the terms of one or more than one contract;
