ORDERS

Director Livestock Gujranwala Division Gujranwala floated a tender for the procurement of Anti-Rabies Vaccines, Medicines and other store items under the project "Birth Control of Stray Dogs through TNVR model in Punjab". A tender notice was published in two daily newspapers i. e. Express Tribune dated 21.05.2021 and Nawai Wagt dated 22 05.2021 and floated on PPRA web site dated 22.05.2021. The technical proposals were opened on 08.06.2021 at 01:30 PM and financial proposals on 08.06.2021 at 02:30 PM in the office of Director Livestock Gujranwala Division Guiranwala by the Purchase / Technical Committee of this office. The two firms M/S Ghazi Brothers Karachi & M/S Huzaifa International Sargodha participated for Anti-Rabies Vaccine in the said Tender. The contract for the purchase of Anti-Rabies Vaccine was awarded to M/S Ghazi Brothers Karachi on the recommendations of Purchase / Technical Committee as they have quoted the lowest rate and supply order for the purchase of 9365 Vials of Canvac-R was given vide No. 2501 dated 18 06 2021.

Breviate of the case is that the last date for the supply of store was 25 06 2021, but the said firm failed to supply the store within stipulated time period even after repeated requests vide No. 2600 dated 22.06.2021, No. 2607 dated 23 06 2021, E-mail dated 23.06.2021, No. 2619 dated 24.06.2021 and E-mail dated 24.06 2021. The Finance Department, Govt. of the Punjab, Lahore fixed last date 25 06 2021 for the submission of bills and there was chance for laps of budget of this project of public interest. It is pertinent to mention here that this was a sensitive and time limit matter because the purchase of Anti-Rabies vaccine is very important component of the said project to save the precious life of humans and animals under the directions of Lahore High Court Lahore

IM/S Chazi Brothers Karachi, submitted invoice of Rs. 73, 51,525/- for 9365 Vilas of Anti-Rabies Vaccines (Canvac-R) vide No. STIV-118132-N bearing batch No. 130720 having expline date od. 2022, that is only 12 months expire against me demand of 18 months expiry as mentioned in supply orders. Because it was

clear cut mentioned in the supply order that the expiry period should not be less than 18 months at the time of supply. It is necessary to mention here that procurement Manager of M/S Ghazi Brothers Karachi vide E-mail dated 21.06.2021 to Director Livestock Bahawalpur Division has stated that he has maximum 12 month expiry of vaccine (Batch No. 130720) and fresh stock is in pipeline and it will be reached in July 2021. It is also agreed by the said firm that if the supply period is not extended by the authority, they are ready to pay the loss of Rs. 68,547/- to Govt. of the Punjab.

On the basis of above mentioned grounds the contract for the supply of said vaccine to M/S Ghazi Brothers Karachi was cancelled on the Recommendations of Purchase Committee vide No. 2632 dated 25.06.2021 and contract was awarded to the 2nd lowest bidder as per PPRA Rules who has supplied the store and bills were processed accordingly. Keeping in view the attitude of above said firm, Director Livestock Gujranwala Division Gujranwala issued a show cause notice to M/S Ghazi Brothers Karachi vide No. 2633 dated 25.06.2021 and the following allegations were leveled against the said firm:

- a) M/S Ghazi Brothers Karachi acted in a manner detrimental to the public interest.
- b) M/S Ghazi Brothers Karachi failed to supply the store and not performed the contract upto the mark.
- c) M/S Ghazi Brothers Karachi submitted bill No. STIV-118132-N of 9365 vials of Canvac-R bearing batch No. 130720 having expiry period of 12 months rather than 18 months.
- d) M/S Ghazi Brothers Karachi submitted bill No. STIV-118132-N without the supply of store which is also a violation of PPRA Rules.
- e) The procurement Manager of M/S Ghazi Brothers Karachi, vide email dated 21.06.2021 to Director Livestock Bahawalpur Division has stated that currently we have maximum 12 months expiry stock available (Batch No. 130720) and also agreed to pay the loss of Rs. 68,547/- to the Government of the Punjab in case the delivery period is not extended and the said firm failed to supply Anti-Rabies vaccine to Director Livestock Bahawalpur, how it could be possible to supply the store to the undersigned.

In response to above referred show cause notice the firm submitted his stance vide No. Nil dated 28.06.2021 and requested to extend time period for response till 15.07.2021. On 15.07.2021 the representatives of the said firm appeared before the undersigned and explained that they will supply vaccine within 10 to 15 days and requested to withdraw the show cause notice and restore the earlier supply order. The undersigned found the reply of firm un-satisfactory as it was

not possible for the authority to extend the delivery period in the next financial year and decided to afford another chance of personal hearing to the firm under class 6 of schedule of blacklisting, mechanism attached with sub class 6 of rule of PPRA 2014 keeping in view the basic principal of law and best interest in justice that "No one should condemned un heard". The date for the personal hearing was scheduled on 14.09.2021 at 11:00 AM in the office chamber of Director Livestock Gujranwala Division Gujranwala in accordance with clause of PPRA Act, 2014 in which Mr. Hafiz Hamid Raza Regional Sales Manager & Dr. Muhammad Muneeb Zia Product Manager, M/S Ghazi Brothers Karachi participated and chair asked some questions regarding the matter but the representatives could not represent any arguments / documents in their defence.

In view of forgoing I' Dr. Khaliq Shafi Director Livestock Gujranwala Division Gujranwala being the competent authority under the Section 17 A of PPRA act 2009 read with rule 21 of PPRA 2014 hereby found that M/S Ghazi Brothers Karachi acted in a manner detrimental to the public interest for good practices, consistently failed to perform obligation under the contract and not performed the contract upto the mark therefore it is debarred / blacklisted for the period of 3 years and it cannot participate in public procurement process.
