The committee has been formulated in line with rule 31 of SPP rules 2010 (Amended 2019) of Sindh Public Procurement Regulatory Authority, notification attached as Annexure A.

A complaint from the Aggrieved bidder was received, letter attached as Annexure B

## **Proceeding of Complaint Redressal Committee**

The committee interviewed the following for detailed examination and verification,

- 1. The bidder representative via virtual meeting
- 2. The chair procurement committee
- 3. Head of Internal Audit

Henceforth; It has been noted by the committee that the point of view of M/s GRESHAM'S EASTERN (PRIVATE) LIMITED, the Aggrieved Bidder, that the demand for the AEDB certification in subjected prequalification is not within the law, and to withdraw the above condition from the bidding documents.

Committee reviewed the prequalification documents and found that the condition was not in contradictory with the rule as mentioned below:

44. Discriminatory and difficult conditions - Save as otherwise provided, no procuring agency shall introduce any condition which discriminates among bidders. In ascertaining the discriminatory nature of any condition reference shall be made to the ordinary practices of that trade, manufacturing, construction business or service to which that particular procurement is related.

In view of the above and in line with the SPP rules 2010 (Amended 2019) of Sindh Public Procurement Regulatory Authority. It has been concluded that the procurement was in complete compliance with the rules 20, 21, 21(A) 27, 28, 29 and 44 as applicable to the procurement, therefore, the compliant of the aggrieved bidder is hereby rejected by the committee.
