Government Contractor approach Chairman Redressal Committee CRC meeting was called vide letter No. TC/GHARO/70/2020, Dated: 07-08-2020 scheduled on 11-08-2020. Accountant of District Council Thatta did not attend the meeting.

As query for Chairman Mr. Muhammad Ali Gaho, concerned Executive Engineer, Education Works District Thatta informed that contractor who complained in Compliant Redressal Committee did not participated in tendering process & no Call Deposit have submitted by them in this office and I Executive Engineer showed the attendance sheet of contractors and members of Procurement Committee where no attendance of Complainant contractor was available.

After through discussion it was agreed that aggrieved bidder did not produce solid evidence for violation made by Executive Engineer concerned CRC after detailed deliberation disposed off complaint against said NIT.
