

**MINUTES OF MEETING OF COMPLAINT REDRESSAL COMMITTEE HELD ON  
13-08-2020 TO HEAR THE GRIEVANCES AGAINST XEN TUBEWELLS DIVISION

A meeting of Complaint Redressal Committee (CRC) constituted vide Irrigation Department Notification No.SO(RS)8-110/218-19 Dated 30<sup>th</sup> December, 2019 was held under the chairmanship of Director Design in Sindh, Irrigation Department Hyderabad @ 28-A, Civil Lines, Hyderabad on 13<sup>th</sup> August 2020 @ 11.00 A.M in connection with complaint lodged by M/s Rustam Khan Chandio regarding Procurement of Goods and Services under O&M/M&R and ADP work for the year 2020-2021. invited by Executive Engineer, Tubewells Division No.I, Hala vide NIT No.SKP/TWD-I/Hala/915 Dated: 29-06-2020.

The CRC has formally examined the grievances/complaints of M/s Rustam Khan Chandio vide his complaint No.RKC-3536 Dated: 05-08-2020 in terms of Rule-31 of SPP Rules-2010 (amended up to date).

The chair briefed the participants about the agenda of the meeting.

Meeting started with recitation of verse of Holy Quran. Chair welcomed the participants and commenced the proceedings.

The Procuring Agency apprised the participants that

1. The instant NIT was invited from the bidders/firms registered with PEC having appropriate specialized codes and eligibility criteria given in NIT & bidding Document in accordance with SPP Rules-2010 (amended up to date) SPPRA Procurement Regulations (WORKS).
2. The NIT was well advertised in leading Newspapers and SPPRA websites No.SKP/TWD-I/Hala/915 Dated: 29-06-2020, but the said NIT was cancelled on 21.07.2020

3. Fresh NIT for single work previously advertised at Sr. No.9 was published vide No.SKP/TWD-I/Hala/1047 dated 24.07.2020.


The Complaint Redressal Committee heard the bidder/complainant as under:

Mr. Rustam Khan Chandio, Proprietor of the firm, confirmed about his complaint lodged by him. He was heard about the contents of his complaint along with replies of Procurement Committee as under:


S. No:	Contents of bidder/complainant	Reply of Procuring Agency
1.	Sir, the Procurement Agency has not clarified whether all the 09 works were cancelled or otherwise.	Sir, all the works were cancelled and new NIT for Single work has been issued namely "Providing and fixing Solar Energy System of New Tubewells of 2.00 Cusecs, Construction of Village Road Culverts 2 Nos & Construction Columns (39 Nos) for Making Direct Disposal of Saline Tubewells along the Embankment of Chotiari Reservoir".
2.	Sir, it is not clarified whether it is under Single Stage Two Envelope or Single Stage One Envelope procurement process.	Sir, it was mistakenly advertised for Single Stage Two Envelope but accordingly corrigendum was issued for Single Stage One Envelope vide Corrigendum No.SKP/TWD-I/Hala/1664 dated 30.07.2020.

**CONCLUSION/DECISION:**

- The Committee examined all the contents of the complaint & concluded that the procurement regime is in accordance with SPP Rules-2010 (amended up to date) SPPRA Procurement Regulations (Works). Therefore the CRC unanimously reject the complaint lodged by M/S Rustam Khan Chandio taking into account the contentions of the complainant & procuring agency in accordance with SPP Rules-2010 (amended up to date).
