The complainant Mr. Salal Khan, proprietor of Noor Enterprises, Government Contractor was called to appear in the meeting vide this office letter No. SE(EWC)/LRK/1236 Dated: 24.08.2020, but he could not appear in the meeting on the scheduled date and time, despite undersigned personally contacted with him on 27.08.2020 & 28.08.2020 on his cell No. 0333-7114450 & 0313-3909146, but he failed to appear in the meeting.
2. Mr. Altaf Hussain Bhurgri Executive Engineer / Procuring Agency, Education Works Division Jacobabad briefed in detail that tenders were invited through his office NIT No: XEN(WED)/TC55/5068 dated 20.07.2020 which was published in the Daily Hilal-E-Pakistan Karachi (Sindhi) dated 26.07.2020, Daily Dawn (English) & Daily Express (Urdu) dated 28.07.2020, and uploaded on PPRA website on 25.07.2020 vide **ID No. T00743-20-0001**. He further narrated that more than 90-contractors participated in the bidding process of 32-works. Neither the above named complainant nor his representative had appeared to participate in the tenders on the scheduled date and time by producing call deposit or tender fee. He also stated that news paper clippings are not mandatory to upload on authority's website and all the complete Bidding Documents including letter of invitation of Bids, instructions for preparing Bids and NIT showing illegibility criteria as alleged by the complainant are uploaded on SPPRA website i.e. ppms.pprasindh.gov.pk, which can be verified at any time.

**Decision:**

After detailed discussion, undersigned as well as CRC Members personally verified the details of NIT bearing No. 5068 dated 20.07.2020 having ID No. T-00743-20-0001 on PPRA website and found all the Bidding Documents, NIT and BOQ's uploaded on the authority's website. Hence, no any violation of SPPRA Rules 2010 (Amended 2019) was observed on the part of procurement agency. It was unanimously decided that the complainant did not participate in the tendering process and failed to prove himself as aggrieved bidder by not producing call deposit and tender fee etc on the scheduled date of submission and opening of tenders as reported by Procuring Agency. So, the contents of complaint are treated as NUL & VOID, and the Procuring Agency is directed to go ahead with further tendering process as required under SPPRA Rules.
