It is stated that the meeting for your grievances was held today on 26-08-2020 under the Chair of undersigned while all members were in full attendance, unfortunately you did not attend. This shows that you have nothing to say in your defense, while the views of Executive Engineer were heard. Following observations were finalized.

1. As you has stated in Para No.01 of your complaint for call deposit and tender fee, but no such proof is attached with your complaint.
2. In para No.02 of your complaint you have alleged that the Executive Engineer Mirpur Division (Irrigation) @ Mirpur Mathelo has refused to received your documents and replied you to take part in the said Bid, whereas 22 Nos. Contractors have participated in the above said bid except you. It shows that the allegation leveled against Executive Engineer Mirpur Division (Irrigation) is false and fabricated.
3. In para No: 03 of your complaint your allegation are totally rejected on the ground that the Executive Engineer Mirpur Division (Irrigation) has awarded the work to his favorite, whereas the 22 Nos. Contractors have participated. The huge Nos. of participants clearly shows that the Tendering process was very much transparent.

Keeping in view the above explained situation your complaint is hereby rejected by the Complaint Redressal Committee.
