

The error was detected & a corrigendum was immediately been issued to the SPPRA authorities website as well as to the National Newspapers vide No: XEN / (EWD) / TC / G-55 / 448, Dated: 01-09-2020 ii). XEN / (EWD) / TC / G-55 / 449, Dated: 01-09-2020 (Annexure "A" & "B").


The tenders are to be issued with correct amount as per corrigendum amount. Thus no loss of tender fees was sustained to the contractors.


The complaint may therefore be filed.
