

MINUTES OF MEETING OF COMPLAINT REDRESSAL COMMITTEE HELD ON 19-08-2020 TO HEAR THE GRIEVANCES AGAINST XEN DRAINAGE DIVISION LBOD, SHAHEED BENAZIRABAD, NIT NO. TC/G-55/1026 DATED: 06-07-2020.

A meeting of Complaint Redressal Committee (CRC) constituted vide Irrigation Department Notification No.SO(RS)8-110/218-19 Dated 30th December, 2019 was held under the chairmanship of Director Design in Sindh, Irrigation Department Hyderabad @ 28-A, Civil Lines, Hyderabad on 19th August 2020 @ 11.30 a.m. in connection with complaint lodged by M/s Milestone Engineering and M/s Muhammad Siddique Engineering Works regarding M&R invited by Executive Engineer, Drainage Division LBOD, Shaheed Benazirabad vide NIT No. (DE0093-20-0001-1 to BE00953-20-0001-3).

The CRC has formally examined the grievances/complaints of M/s Milestone Engineering and M/s Muhammad Siddique Engineering Works vide there complaint No. Nil Dated 10-08-2020 and No.C/LBOD-SBA/001 dated 30th July 2020 respectively in terms of Rule-31 of SPP Rules-2010 (amended up to date).

The chair briefed the participants about the agenda of the meeting.

Meeting started with recitation of verse of Holy Quran. Chair welcomed the participants and commenced the proceedings.

The Procuring Agency apprised the participants that

1. The instant NIT was invited from the bidders/firms registered with PEC having appropriate specialized codes and eligibility criteria given in NIT & bidding Document in accordance with SPP Rules-2010 (amended up to date) SPPRA Procurement Regulations (WORKS).

2. The NIT was well advertised in leading 06 Newspapers and SPPRA websites @ ID No: (DE0093-20-0001-1 to BE00953-20-0001-3).
3. The technical bids/proposals will publicly be opened 1st attempt on 27-07-2020 and 2nd attempt on 11.08.2020.

The Complaint Redressal Committee heard the bidder/complainant as under:

The authorized representatives of the firms, confirmed about their complaint lodged by them. They were heard about the contents of their complaint along with replies of Procurement Committee as under:

S. No:	Contents of bidder/complainant	Reply of Procuring Agency
1.	Sir, on 27.07.2020 I came to office of the Executive Engineer LBOD SBA to submit my bid alongwith Pay Order but PA refused to receive my documents and stated that tenders have already been allocated to favourites.	Sir, the allegation is denied as total of 18 bidders participated in the tendering process, however, 11 bidders alongwith pay orders. The companies "M/S Milestone Engineering and M/s Muhammad Siddique Engineering Works" never attended or participated in the bidding process (Attendance Sheet attached).

CONCLUSION/DECISION:

- The complaint of the bidders/complainants is **not maintainable** as they have not participated in the Tendering Process, however, the Committee examined all the contents of the complaint & concluded that the procurement regime is in accordance with SPP Rules-2010 (amended up to date) SPPRA Procurement Regulations (Works). Therefore the CRC unanimously reject the complaints lodged by M/S Milestone Engineering and M/s Muhammad Siddique Engineering Works taking into account the contentions of the complainants & procuring agency in accordance with SPP Rules-2010 (amended up to date).
