9. M/S Ibrahim Solangi Construction Company/Complainant.


The chairman welcomed all the participants and subsequently informed the forum about the complaints made by above named Contractors/Firms for the procurement of works related to NIT No. XEN(EWD)/CB/TC/G-55/615 dated 18.08.2020 issued by Procuring Agency/ Executive Engineer, Education Works Division, Larkano.


1. All the above named Complainants were heard in detail. The Chairman CRC asked them to produce the relevant documents viz: Call Deposit (in original), Relevant Experience, Financial Turnover of last three years as required in the NIT referred above. The Chairman also asked them whether you recognize the Executive Engineer/Procuring Agency concerned sitting here (in the office room) against whom you have quoted in your complaint that the Chairman of Procuring Agency did not allow you to drop tender in the Tender Box and threats you time to time. All the complainants failed to produce the required documents and even could not recognize the Chairman of Procuring Agency already sitting before them. Due to their failure, they agreed to withdraw their complaints made against the Procuring Agency/Executive Engineer, Education Works Division, Larkano in connection with procurement of works.


Decision:

After detailed discussion, it was unanimously decided that all the complainants as mentioned above were totally failed to produce themselves as aggrieved bidder, so they agreed to withdraw their complaints. Therefore, the contents of complaints are treated as NUL & VOID. The Procuring Agency concerned is directed to go ahead with further bidding process subject to fulfillment of all codal formalities in accordance with the SPPRA Rules 2010 (Amended 2019).
