Complaint Redressal Committee Proceedings

The meeting was started with name of Almighty Allah. The Project Manager, Project Implementation Unit, Hyderabad-Mirpurkhas Dual Carriageway Project, Hyderabad / Chairman Complaint Redressal Committee welcomed all the participants for attending meeting and narrated the purpose of holding meeting. He informed that M/S Allah Dino Burdi, Government Contractor have lodge complaint / grievance on the Tenders invited for procurement of different works in office of the Executive Engineer, Provincial Highways Division, Shaheed Benazirabad, vide letter No: TC/G-55/995 Dated 06-10-2020 therefore, inorder to redress their grievance this meeting is conveyed as per Rule-31 of

SPPRA Rules 2019 (Amended 2019), Government of Sindh. Then the chair asked the appellant / complainant M/S Allah Dino Burdi, Government Contractor, to present his case / version on the instant procurement before the committee.

The Complainant M/S Allah Dino Burdi, Government Contractor complain that, he approached office of the Executive Engineer, Provincial Highways Division, Shaheed Benazirabad office for issuance of Tender documents but the tender documents was not issued to him by the staff of Executive Engineer and also the tender documents could not download from SPPRA website.

Procuring Agency's Version.

Mr. Abdul Majeed Panhyar, Executive Engineer, Provincial Highways Division Shaheed Benazirabad / Chairman Procurement Committee has informed that the tender documents was issued to all the willing contractors & also uploaded on the SPPRA website for downloading, but complainant never visited his office for issuance of tender documents and he further informed that many contractors downloaded the tender documents from SPPRA website and submitted to his office through TCS & in person, also the complainant submitted the bidding documents and participated in the procurement process. The allegations leveled by complainant are baseless and false and just to create hindrance in the procurement process.

Decision of Complaint Redressal Committee

After hearing both the parties and detailed discussion, the members of the Complaint Redressal Committee unanimously agreed upon the decision that the allegations leveled by the complainant are baseless and false.
