
1. The above named Complainant was heard in detail. He was fully satisfied with the arguments / facts narrated by the officials of the Executive Engineer/Procuring Agency about issuance of bidding documents in proper manner to all bidders/participants and opening of bids on the scheduled date i.e 28-07-2020 at 2:00 p.m, hence he agreed to withdraw his complaint dated 26-10-2020.
2. The Procuring Agency concerned stated that due to typing mistake, the date for opening of bids/tenders had been mentioned as 27-07-2020 instead of 28-07-2020. The same was corrected through a corrigendum vide No.XEN/EDU:/(W)/167 dated 10.07.2020 under intimation to all bidders/participants. Accordingly, the tenders were opened on the scheduled date i.e 28-07-2020 at 2:00 pm. All the Bidders/Participants (61 Nos.) shown their attendance in the Attendance Sheet, which is the ample evidence of opening of bids on 28-07-2020.


Decision:

After detailed discussion and scrutiny of all the bidding documents, it was unanimously decided that the complainant being satisfied with the facts/arguments of the procuring agency concerned agreed to withdraw his complaint dated 26-10-2020. Besides, no any violation was observed on the part of the Procuring Agency.
