Complaint Redressal Committee Proceedings

Division, Shaheed Benazirabad, vide letter No: TC/G-55/995 Dated 06-10-2020 therefore, in order to redress their grievance this meeting is conveyed as per Rule-31 of SPPRA Rules 2019 (Amended 2019), Government of Sindh. But the complainant was absent in the meeting. In absence of complainant the chair asked the Executive Engineer, Provincial Highways Division, Shaheed Benazirabad / Chairman Procurement Committee to present his case / version on the complain before the committee.

Procuring Agency's Version.

Mr. Abdul Majeed Panhyar, Executive Engineer, Provincial Highways Division Shaheed Benazirabad / Chairman Procurement Committee informed that the tenders are invited as per SPPRA Rule 12 (b) and as per approval of Divisional over Sight Committee. The allegations leveled by complainant are baseless and false and just try to disturb the procurement process.
