BEFORE COMPLAINT REDRESSAL COMMITTEE UNDER RULE NO:31 OF SPPRA RULES 2010.

FACTS AND BACKGROUNDS:

A meeting of Complaint Redressal Committee was held on 12.11.2020 at 12:00 Noon in office of Chief Engineer, Highways Hyderabad / Chairman Complaint Redressal Committee in connection with complaint made by M/S. E.A Consulting (Pvt:) Ltd: regarding his grievances for the work namely "Consultancy services for review of Detailed Design & Construction Supervision of road from National Highway (N-5) Dhabeji Creeks side at mile 31/0 (50.00 Kms) to connect Port Qasim Dual Carriageway (8 Kms) Dhabeji Special Economic Zone (CPEC)." invited by the Executive Engineer, Provincial Coastal Highway Division, Hyderabad vide NO:TC/G-55/CHD/845, dated:30.07.2020 (ID NO.E00592-20-0002).

The Chair welcomed to all the participants and started the meeting with name of Almighty ALLAH.

1. EA Consulting (Pvt:) Ltd: (Version):

Mr. Imran Soomro Representative of EA Consulting (Pvt:) Ltd: stated that they submitted their technical & financial proposal for the above-mentioned project on 20th August 2020. Initially Technical proposal was opened on the same date, whereas financial proposal opened on 21.09.2020. The Executive Engineer, Provincial Coastal Highway Division, Hyderabad, announced Technical qualification report and invited vide his letter NO:TC/G-55/CHD/1149 dated:17.09.2020 to attend the meeting for financial opening bids.

He further told that the financial proposals were opened in the presence of representative of M/S. Zeeruk International (Pvt:) Ltd: & EA Consulting (Pvt:) Ltd: but financial bid was neither announced loudly nor shown to the representatives as required under Rule 41(5) of SPPRA Rule 2010 & clause 19.1 section 2 information to consultants mentioned in RFP issued by the Executive Engineer Provincial Coastal Highways Division Hyderabad.

He further pointed-out that minutes for opening of bids were not issued, which is mandatory as per Rule 41(9) of SPPRA Rule 2010. The Bid Evaluation Report hoisted by Executive Engineer Provincial Coastal Highway Division Hyderabad at SPPRA website on 2nd October 2020 were not according to SPPRA Rules. The Evaluation of Bids has not been conducted in fair manner, and insisted to declare the process as Mis-Procurement.

2. Chairman Consultant Selection Committee's Version:

Syed Turab Ali Shah, Chairman Consultant Selection Committee / Superintending Engineer, Provincial Highways Circle, Hyderabad stated that Financial proposal of complainant was opened in presence of authorized representative of M/S. EA Consulting (Pvt:) Ltd: and were announced before them. The representative also signed the attendance sheet and photocopy of the same was produced as a documentary proof.


As per evaluation report, M/S. EA Consulting (Pvt:) Ltd: secured 85.60 score only whereas, successful bidder secured 96.87 score. According to clause 19.4, the firm achieving the highest combined technical and financial score will be invited.


The technical and financial evaluation report duly supported with all relevant documents were hoisted on SPPRA website as per SPPRA Rules.


3. Complainant Redressal Committee's Decision:

After the hearing both parties at length, and going through the relevant procurement record, the complainant could not prove his allegations. The result of Technical & Financial proposals were loudly announced in presence of authorized representative of M/S. EA Consulting (Pvt:) Ltd: (Complainant) as well as representative of M/S. Zeeruk International (Pvt:) Ltd: and the consultant selection committee recommended to award the contract to the consultant securing highest combined technical and financial score. No violation of SPPRA Rules was made, hence the complaint was rejected / dismissed.

The meeting ended with a vote of thanks from and to the chair.
