

## MINUTES OF MEETING

## MEETING OF THE COMPLAINT REDERESSAL COMMITTEE ON THE COMPLAINT OF M/S FAQEER MUHAMMAD MITHAL MANGRIO & SHAFQAT ALI KATPER & SONS.

A meeting on the captioned subject was held under the Chairmanship of Special Secretary Technical, Local Government on 18<sup>th</sup> November 2020 at 4.00 p.m in the office of Special Secretary Technical, Local Government Department, **(List of participants attached)**.

At the outset the chairman welcomed all the participants and opened the forum to discuss the issues pertaining to Complaint Redderssal Committee on notice inviting tender ref/-No.(T01457-20-0002 procurement of (12) works / NIT NO.XEN/TCL/LGP/GOS/G-55/300/2020 SUKKUR DATED 25.09.2020 & XEN / TC/ LGP /GOS/G-55/309/2020 dated 17.11.2020.

**Complainant No.1** M/S Faqeer Muhammad Mithal Mangrio and **Complainant No.2** M/S Shafqat Ali Katpar & Sons are brief that bid data sheet envisage two different types of contract i.e Fix price contract and price adjustment contract whereas the procuring Agency was is required to choose any one.

2. Procurement Committee informed that the SPPRA vide letter No. D.D(A)/SPPRA/(TO1457-20-0002)/2020-211453 dated 18.11.2020 addressed to the Project Director Local Government Project Hyderabad has also mentioned the same issue and gist of the letter is as under :

- Bid data sheet envisage two different types of contract i.e Fixed Price contract and Price adjustment contract. The P.A is required to choose any one.
- ii) In terms of Rule-47(1) Single Stage One Envelope bidding procedure shall be used as the standard bidding procedure for procurement of goods, works and services of simple and routine nature and where no technical complexity or innovation is involved. However, in the instant case, which seems to be simple and routine nature, the procurement agency has used single stage two envelope procedure. Procuring Agency is advised to furnish justification for the same.
- iii) Procuring Agency has mentioned the evaluation criteria in NIT only Whereas, in terms of Rule-21(1) (h) read with Rule-21(A) bidding documents must contain a detailed and unambiguous evaluation criteria. The procuring agency is therefore advised to make the evaluation criteria part of the bidding documents. The procuring agency is required to provide a clear and unambiguous evaluation criteria and extend the response time accordingly.

## Decisions

Complaint Redressal Committee decided that NIT under Single Stage One Envelope bidding procedure as per SPPRA Rules may be called afresh and previous tender process may be quashed.
