MINUTES OF THE COMPLAINT REDRESSAL COMMITTEE (CRC) MEETING HELD ON 06-01-2021 TO HEAR THE COMPLAINT / GRIEVANCES AGAINST EXECUTIVE ENGINEER IRRIGATION EAST DIVISION KHAIRPUR RELATING TO NIT BEARING NO. TC/G-55/1753 DATED 17-11-2020.

#### Back Ground:-

- Chief Engineer Sukkur Barrage Left Bank Region Sukkur constituted Complaint Redressal Committee vide Notification No. WB-11/CRC/2020/4-W/ 4456 dated 26-11-2020 in pursuance of Secretary to Government of Sindh Irrigation Department Karachi's Order No. SO (R&S)/8-110/ 2019-20/Part-XII/1706 dated 16-10-2020 and in accordance with Rule-31(1) of Sindh Public Procurement Rules 2010 (Amended 2013).
- 2. The Complaint Redressal Committee meeting was convened on 06-01-2021 at 02-00 P.M. in the office of Superintending Engineer / Chairman (CRC) Khairpur Irrigation Circle Sukkur for hearing of grievances / complaints of above cited/ mentioned bidders / complainants in connection with NIT invited by the Executive Engineer Barrage Division Sukkur bearing No. TC/G-55/ 1753 dated 17-11-2020.

#### Proceeding / Decision :-

The complainant attended the meeting of CRC on 06-01-2021 and stated that he was issued tender form which has been submitted by him to the Procuring Agency through Courier service. He has further reported that he attended the office of Procuring Agency on 08-12-2020 where no one was available.

In this behalf the Executive Engineer Irrigation East Division Khairpur during the meeting on 06-01-2021 presented his report in the matter whereby he has reported that due to his appearance in the Honourable High Court of Sindh Bench at Sukkur in CP No. D-857 /2020 filed by Fazul Hussain Mari Versus Province of Sindh & others on 08-12-2020 it was not possible to open the tenders on 08-12-2020, accordingly he has issued a corrigendum bearing No. TC/G-55/1900 dated 08-12-2020 for receiving back of the tenders on 24-12-2020 and opening of tenders on same date at 1-00 P.M. as a second attempt. The Executive Engineer Irrigation East Division Khairpur has provided copy of Honourable Court Notice / Summon and corrigendum in support of his version which are attached herewith.

In this connection it was informed by the Executive Engineer Irrigation East Division Khairpur that the bids were opened on 24-12-2020 at 1-00 P.M. as per fixed date and time as envisaged in the corrigendum by the procurement committee in presence of all the participating bidders / government contractors. The complainant has not attended his office on 24-12-2020 up-to the time of opening of the bids. The Executive Engineer Irrigation East Division Khairpur has provided a copy of attendance sheet of all the participating bidders / Government contractors which is attached herewith.

Keeping in view the above circumstances the Complaint Redressal Committee is of the unanimous opinion that there is no substantial anomaly / ambiguity in procurement process, therefore the procurement process is valid.
