A CRC meeting was held under the chairmanship of Superintending Engineer/Chairman CRC, Education Works Circle Larkano in his office on 04.02.2021 to decide the complaints in terms of Rules-31(3) & (5) of SPP Rules, 2010 (Amended 2019). Following attended the meeting.

The chairman welcomed all the participants and subsequently informed the forum about the complaints made by above named Contractors/Complainants regarding procurement of works related to NIT No. XEN(EWD)/CB/TC/G-55/1346 dated 18.12.2020 issued by Procuring Agency/ Executive Engineer, Education Works Division, Larkano.

- All the above named Complainants were heard in detail. The Chairman CRC asked them to produce the
 relevant documents viz: Call Deposit (in original), Relevant Experience, Financial Turnover of last three
 years as required in the NIT referred above. All the complainants failed to produce the required documents
 except Pay Order only.
- 2. The Executive Engineer/Procuring Agency, Education Works Division Larkano briefed that the tenders/bids were opened on the scheduled date i.e 25.01.2021 at 2:00 p.m in the presence of all interested bidders or their authorized representatives and more than thirty five bidders participated in the bidding process.

Decision:

After detailed discussion, it was unanimously decided that all the complainants as mentioned above were totally failed to produce the relevant documents before the forum and could not prove themselves to be eligible bidder to fulfill the requirements of the NIT concerned. Thus, the contents of the complaints are treated and NUL & VOID. The Procuring Agency concerned is directed to go ahead with further bidding process subject to fulfillment of all codal formalities in accordance with SPPRA Rules 2010 (Amended 2019).
