The Complainant's Version.

The complainant stated that he couldn't attend the 1st CRC meeting due to his marriage and on the 2nd meeting he has come to attend and his version is stated in the application and the same should be counted his version.

Procuring Agency's Version.

Executive Engineer, Engineering Wing S&YAD, Karachi stated before the CRC that following NITs of Schemes were published in newspaper as well as hoisted on SPPRA website.

The Executive Engineer further stated that M/s Ghulam Murtaza Enterprises had submitted complaint addressed to Managing Director SPPRA Sindh Karachi and Secretary / Chairman Complaint Redressal Committee S&YAD vide No. GME/118 dated 26th January 2021. The Section Officer (Dev) vide their letter No. SO (D)/S&YAD/2020-21/58 dated 02nd February 2021 called Parawise comments from Chief Engineer Engineering Wing Sports & Youth Affairs Department.

He further stated that the same replies may kindly be considered the version of the Executive Engineer/Procuring Agency.

same was not issued for award his blue eyed contractors on high rate, Moreover complainant have some confusions & observation under the Rule 23 the complainant write a letter to Secretary, Sports & Youth Affairs Department & to Chief Engineer and XEN Civil for Clarification and for his imposing illegal terms & conditions but no any action has been taken. Shipment of complainant was refused by the Procuring Agency i.e XEN Civil Sports & Youth Department.

any letter / application has been received in the office, via mail / courier, prior to opening of bid for clarification regarding imposing illegal terms & conditions. However his complaint which he had made on 19-01-2021 was received in the office for para wise comments through Section Officer (Dev) Sports & Youth Affairs Department vide letter No. SO /(D)/S&YAD/2020-21/1453 dated January, 2021, received in the office of chief Engineer on 25th January after opening of bid. It is pertinent to mention here that as per SPPRA Rules-46 (1)(1) relevant experience was asked which is part & parcel / mandatory for the Bidders to avoid any complication at a later stage on which he should not have any reservation as it is not in contravention of SPPRA Rules.

iv. That the Complainant down loaded Bidding Documents and attached Original Call Deposits for Bid Securities and pay orders for DR/ Tenders fees in Proposal and filled the rates proper sealed it sent to Executive Engineer (Civil) Sports & Youth Affairs Karachi by TCS courtier shipment No (2066932540) & same was also refused, which is violation of SPPRA Rules of TCS Shipment History enclosed)

Not agreed with the statement of the complainant. No any bid was received through TCS in this office. However, this office exists in State life building having five floors and is occupied by various government offices. This office did not know in which office the shipper approached for delivery of TCS shipment, moreover complainant was asked to tell the name of person who refused to received the shipment but he could not tell the name of the refuser.

On the enquiry from the TCS office through telephone by CRC Committee they also told that no any name of refuser was mentioned and on asking about weight of the shipment they told it was 0.5 kg. where as the weight of all nine NITs for which the complainant claims was about nine times more than the weight told by the TCS office/enquiry i.e (0.5 Kg). Therefore it contradicts the statement of the complainant and proves that he is misstating just to blackmail the Procuring Agency.

Not agreed. It is stated that on the date of opening of bids on 25th January, 2021 at 2. P.M, Procurement Committee was present consisting of **5 members**, Chief Engineer S&YAD (Chairman), Executive Engineer Civil, S&YAD, (Member) Deputy Director Industries Department (Member), Divisional Accounts Officer A.G Sindh, (Member) and SO (Development) (Member).

20 to 25 bidders who were participating in the bidding were present (Attendance sheets proves their presence).

All the procedure of opening of bids was adopted by the Procuring Agency as per SPPRA Rules before the bidders by the Procurement committee. Therefore the question of issuance of corrigendum not arise because neither date was postponed nor cancelled.

The above position clearly proves that complainant was giving totally fake statement.

vi. That Sir above mentioned facts clearly show and it is proved that the was not a open competition but are illegally managed tenders by Chief Engineer & Executive Engineer Sports & Youth Affairs Karachi to award these works to their favorite and specific persons through illegal way by not conducting the fair and transparent procurement process, as there were also observation made by SPPRA Head Office Karachi, but the XEN did not care for such observations and misused his powers for award his blue eyed contractor on favoritism basis in huge loss of Govt. on high rate.

This office /Procuring Agency believes in free, fair, open and transparent procedure of follow and process bidding Rules/Regulations Of SPPRA therefore the open competition among the genuine Bidders was held in front of about 20 to 25 bidders/participants applied who members of the Procurement committee, following the prescribed procedure under SPPRA rules opened the bids, announced the rates loudly and signed all the papers/documents on the date and time i.e 25th January, 2021 at 1400 hours. Therefore the question of favoritism/nepotism does not arise at all.
