

MINUTES OF COMPLAINT REDRESSAL COMMITTEE MEETING HELD UNDER THE CHAIRMANSHIP OF SUPERINTENDING ENGINEER PROVINCIAL HIGHWAYS CIRCLE LARKANO / CHAIRMAN (CRC) DATED: 24-02-2021.

The Chairman welcomed to all the participants in meeting.

Meeting of Complaint Redressal Committee (CRC) was held on 24-02-2021 at 02:45 (noon) in the office of the Superintending Engineer, Provincial Highways Circle Larkano in accordance with the SPPRA Rule 31(4) & (5) of Sindh Public Procurement Rules-2010 (Amended up to date) to look into complaints made by the following Firms / Contractors versus the Executive Engineer, Provincial Highways Division Larkano / Procuring Agency against the above subjected NIT.

Accordingly all (06) No. of above complainants as well as Executive Engineer concerned / procuring agency have been issued letter vide No. SE(PHWC)BB/314 dated 19-02-2021 has been requested to attend the meeting of Complaint Redressal Committee on 24-02-2021 so as to ascertain the factual position / matter and redress the grievances.

Out of (06) No. of complainants only 03 Nos. namely Reliant Trade Link at Sr. No.2, M/S Waqar Enterprises Sr. No.4 and M/S Raja Panhyar at Sr. No.6 attended the Complaint Redressal Committee Meeting and rest of the complainants failed to attend the Meeting (Copy of Signature / Attendance Sheet is attached for ready reference).

While going through the contents of complaint made by M/S Reliant Trade Link, Government Contractor wherein he argued that Procurement Committee did not completed that required formalities / quorum as well as-not placing the Tender Box in his office which reflects the malafide while violation the SPPRA Rules and adopted the pick and choose policy in above NIT called by the Executive Engineer, Highways Division, Larkano / Procurement Agency.

In response to above, Forum asked to the Executive Engineer / Procuring Agency to clarify his position during the course of meeting; he replied that complainant M/S Reliant Trade Link did not participate in the tendering process and his complaint is baseless. Despite that tendering process has been made in accordance with the SPPRA Rules in absolute transparent manner all sealed tenders of interested bidders were opened before the Procurement Committee and in the presence of participated bidders / contractors; which is quite evident that except the complainant all (110) interested bidders / Contractors participated in the tendering process which he has produced before the Redressal Committee (photo copy of signatures sheet of participated bidders are attached for ready reference).

However, the contents of complaint made by M/S Waqar Enterprises Government Contractor wherein he has also alleged the same allegations likewise above contractor M/S Reliant Trade Link that Procurement Committee did not completed that required formalities / quorum as well as not placing the Tender Box in his office which reflects the malafide while adopting the pick and choose policy and awarded the contracts to his favourite persons / contractors in above NIT called by the Executive Engineer, Highways Division, Larkano / Procurement Committee.

In response to above, Forum asked to the Executive Engineer / Procuring Agency to clarify his position during the course of meeting; he replied that complainant M/S Waqar Enterprise did not participate in the tendering process and his complaint is baseless. Despite that tendering process has been made in accordance with the SPPRA Rules in absolute transparent manners and all sealed tenders of interested bidders were opened in the presence of the Procurement Committee as well as participated bidders / contractors; which is quite evident that except the complainant all (110) interested bidders / Contractors participated in the tendering process which he has produced before the Redressal Committee (photo copy of signatures sheet of participated bidders are attached for ready reference).


However, Mr. Waqar Ahmed Jatoi, Proprietor M/S Waqar Enterprises denied the same before the Redressal Committee and alleged that I have participated in the tendering process called by the Procuring Agency but my Call Deposits amounting to Rs.2,113,000/- and Rs.2,853,000/- are still lying with the Executive Engineer concerned, but he did not provide such receipt copies of the same before the Redressal Committee, hence his allegation remain unjustified.

Accordingly, the contents of complaint made by M/S Raja Panhyar has been examined which reflects the allegations against the Chairman Procurement Committee / Executive Engineer concerned that he attended in the office concerned on tendering opening date and time and recorded the venue on his cellular / mobile device that Procurement Committee was not available in the office concerned. Resulting in the Executive Engineer / Procuring agency adopted the pick and chooses policy while awarded the work to his blue eyed contractors on the basis of huge money and bribe.

In response to above, the Executive Engineer / Procuring Agency vehemently denied the allegations leveled by M/S Raja Panhyar and replied that complainant did not participate in the tendering process and he might have recorded the venue before or after the tendering process therefore his complaint is baseless. Despite above, tendering process was completed in absolute transparent manner and all sealed tenders of interested bidders were opened in the presence of the Procurement Committee as well as participated bidders / contractors. (However, photo copy of signatures sheet of participated bidders are attached for ready reference).

In light of the above discussion the Committee concluded and decided that all (110) interested bidders / contractors have participated in the process; therefore; instant complaints which do not carry the weight-age in this regard.
