Complaint Redressal Committee was arranged in response to complaints against NIT No.TC/847 dated 22-05-2019 for Works of Public Health Engg: Division No. I, Hyderabad. The NIT was hoisted on SPPRA Website & as well as published in news papers. Complaints M/s Abdullah Soomro Construction Company approached Chairman Complaint Redressal Committee. CRC meeting was called vide letter GM/PHED/CRC/1733, dated 22-08-2019 scheduled on 27-08-2019 District Accounts Officer Hyderabad did not attend the meeting.

On quarry from chair, Mr. Abdul Rasheed Bhutto informed that contractor did not acquire requisite passing marks i.c 50 out of 100 in pursuance to prescribed evaluation criteria, particularly experience in similar field of RO plants. Contractor admitted that he has no experience in field of RO plants.

After thorough discussion it was examined that aggrieved bidder did not produce solid evidence for violation made by Executive Engineer concerned. CRC after detailed deliberation disposed off complaint against said NIT.

Meeting ended with vote of thanks from and to the Chair.
