

The Chair welcomed to all the participants and informed that the basic purpose of the meeting was to go through allegations leveled by the **M/S AMB & Co: Government Contractor (Complainant)** in connection with tenders invited by the Executive Engineer, Provincial Highways Division, Badin vide NIT No: TC/G-55/-556 dated 04-05-2021 opened on 25-05-2021 (1st Attempt).

The Chair asked to the complainant as well as the Executive Engineer Provincial Highway Division Badin to brief the committee regarding allegation one by one.

M/S AMB & Co:

The complainant stated that they had some grievances regarding bidding process, but the Executive Engineer explained that the condition mentioned in the bidding documents were according to the SPPRA Rules and the rates of Sindh Sales Tax were introduced by SRB. After his clarification they had no further grievances regarding bidding.


REPLY OF THE EXECUTIVE ENGINEER


The Executive Engineer, Provincial Highways Division, Badin stated that the complainant has already been properly explained regarding the rates of SST and the procedure of its inclusion as well as deduction from the bills, otherwise there is no question of extending undue favour to any particular contractor and the entire procurement process was transparent and according to SPPRA Rules 2010 (Amended 2019).


DECISION:-

The Committee decided that the complainant has expressed his satisfaction regarding bidding procedure and the reason for incorporation of SST hence, the complaint was dismissed.

The meeting ended with a vote of thanks from and to the Chair.





