The Chair welcomed to all the participants and informed that the basic purpose of the meeting was to go through allegations leveled by the **M/S ABDUL HAFEEZ KOLACHI Government Contractor (Complainant)** who has challenged the single stage two envelope procedure of tenders and stated that the tender invited by the following Provincial Highways Divisions are in contravention to SPPRA Rules.


In this connection, meeting of the complaint Redressal Committee (CRC) was fixed on 24-12-2021 @ 10:30 A.M vide this office letter No.TC/G-55/2602 dated 20-12-2021. The Members of complaint Redressal Committee attended the meeting at fixed time but the M/s Abdul Hafeez Kolachi, Government Contractor (Complainant) failed to attend the meeting.


However, the Executive Engineer of each Division informed that the tender were invited by them according to SPPRA Rules 2010 (Amended 2019) and no violation has been made, but the complainant is creating un-necessary hurdles for his ulterior motives.

DECISION:-


The Members of CRC decided that the complainant was required to attend the meeting to explain his grievances but he was failed to attend the meeting. Whereas, the single stage two envelope procedure of tenders is according to SPPRA Rules and such decision has already been given by SPPRA Review committee meeting held on 10-02-2021, in connection with complaint filed by the same complainant, wherein, it was clearly stated that decision lies with the procuring agency to take decision regarding the method of procurements according to the nature of work, circumstances of needs of the procuring agency. Therefore, the complaint filed by M/s Abdul Hafeez Kolachi is dismissed.

The meeting ended with a vote of thanks from and to the Chair.







