

PROCEEDING OF CRC.

The committee thoroughly read the complaints of complainants and also heard.

Aggrieved Complainant.	Complainant version	Reply of the Procuring Agency
M/S Din Muhammad Enterprises & Builder	The contention of complainant that the rates were not declared at the time of opening and he stated that at the time of opening he was only present for dropping / polling of Bidding Documents. The other bidders were illegally entered in Bidding process, so that the NIT is Fake and may kindly be cancelled otherwise he will not signed on the attendance sheet.	In the contra version said that 12 Nos. Bidders are participated and polled their Bidding Documents in tender Box including complainant & 2-Nos. Bids were received through TCS. The sealed envelopes were opened before committee and participants. The name of bidder, Bid Security, Name of Bank and Rates were announced loudly at the time of opening. In the support the procuring agency provided evidences i.e- attendance sheet photos / videos and Comparative Statement.
M/S. Muhib Ali Sadhayo	The Complainant M/s. Muhib Ali Sadayo filled the application regarding violation of SPPRA Rules at the time of Opening Bids by the Procuring agency. Representative of M/s. Muhib Ali Sadayo present before the CRC and narrated to Chairman CRC that he was legal advisor of complainant, due to emergent work at High Court Hyderabad he will returned back at 03.00 P.M.	In the contra version The Procuring Agency said that the complainant was not participated in person at the time of opening, his Sealed envelope received through TCS and opened before the committee. Due to in- complete documents of the Complainant M/s. Muhib Ali Sadayo, the Procurement Committee declared as Un-responsive Bid and not entertained in Bidding Process. 
COMMITTEE FINDING:-


1. The committee observed that no any evidence were provided by M/s. Din Muhammad Enterprises Builders regarding violation of SPPRA rules.
2. The Committee observed that the complainant M/s. Muhib Ali Sadayo was lack^f interest to attend the CRC. Because of his representatives (Legal Advisor) said that he will returned back at 03.00 P.M before CRC. The committee waited for and called on Cell Phone at 03.00 P.M, He informed that he has deputed his representative to attend the CRC meeting but till 04.00 P.M no any representatives appeared before CRC.

DECISION OF CRC:-

In view of above, the committee unanimously decided that the Procurement Regime is in accordance with SPPRA Rules 2010 amended up to date and the Complainant's complaints are redundant and baseless. Therefore, the same are hereby dismissed / rejected accordingly.
