The Chair welcomed the participants and briefed that the tenders were invited and opened in the presence of bidders/ representatives by the Procurement Committee. However, a complaint was lodged by M/s Peacock Printers & Publishers against the bidding process.

The Complainant raised the objection on Mr. Noor Ahmed Memon to be the member of Complaints Redressal Committee and stated that being having a member of Procurement Committee; he should have not been participated in the meeting of Complaints Redressal Committee. The Chair in principle agreed with the objection of complainant and directed that in future no any owner of the particularly Company should be designated as a member of Complaints Redressal Committee.

M/s Peacock Printers & Publishers alleged that the rates have been tempered and changed in the bid of favorite. However, the rates showing by him were not tally with the comparative statement. On questioning, the complainant himself admitted that he was not present at the time of bidding and such rates were given to him later on.

Deputy Director / In-charge publication was also asked to inform the actual position, who completely denied the allegations and stated that the entire process of bidding was very much transparent and as per SPPRA rules.
