MINUTES OF CRC MEETING HELD UNDER THE CHAIRMANSHIP OF SUPERINTENDING ENGINEER / CHAIRMAN CRC, EDUCATION WORKS CIRCLE LARKANO ON 22.02.2022 @ 3.00 p.m.

A CRC meeting was held under the chairmanship of Superintending Engineer/Chairman CRC, Education Works Circle Larkano in his office on 22.02.2022 to decide the complaints in terms of Rules-31(3) & (5) of SPP Rules, 2010 (Amended 2019). Following attended the meeting.

The chairman welcomed all the participants and subsequently informed the forum about the complaint made by M/S Muhib Ali Sadhayo, Govt. Contractor Construction Company/ Complainant regarding adopting Single Stage Two Envelope Bidding Procedure through NIT No. XEN(EWD)TC/G-55/153 dated 10.02.2022 issued by Procuring Agency/ Executive Engineer, Education Works Division, Larkano.

- Consequent upon receipt of a complaint, the Chairman CRC called all the parties i.e M/S Muhib Ali Sadhayo, Govt. Contractor Construction Company and the Procuring Agency through his letter No. SE(EWC)LRK/143 dated 21-02-2022 to appear in the CRC meeting on the scheduled date & time as referred above.
- 2. On query, Mr. Imran Khan having CNIC # 4550503721497 an authorized representative of above referred company could not brief about a qualified Govt. Contractor. He further stated that he had been authorized by M/S Muhib Ali Sadhayo, Govt. Contractor/Complainant, who is his father by relation. Moreover, He (Mr. Imran Khan) could not brief about his complaint against the Procuring Agency. Besides, the complainant in his complaint dated 18-02-2022 states that the procuring agency has adopted the Single Stage Two Envelope Procedure, which is against the Rule No. 47(1) as the works/contracts shown in the NIT are of simple routine nature works and do not need any Technical Complexity or Innovation so single stage single envelope procedure must be adopted in the instant NIT to ensure transparency and fairness in the bidding procedure.
- The Procuring Agency i.e Executive Engineer, Education Works Division, Larkano stated that the building work is very typical, critical and contains numerous items of work. The contractors having the experience of roads, drains and expertise of other non-structural works, intend to participate in bidding of works and at later stage could not deliver the required quality and progress of works. Moreover, he stated that the contractors exert undue pressure tactics from different corners to get the contract and cause hindrance in the tendering process. Different contractors make group and jeopardize the bidding process. The Procuring Agency also stated that non-professional and non-serious contractors quote the non-realistic and unworkable rates, which ultimately affects the quality and progress of works and the lowest rates for works are announced at the time of opening of bids and evaluation criteria is to be verified later, which creates unnecessary disputes, which becomes unmanageable sometimes. Considering these facts in view, the Single Stage Two Envelope Procedure is adopted in terms of Rule-47(2) to avoid law and order problem in the office.
- 4. CRC forum observed that the procuring agency is empowered to choose any method of procurement by observing SPP Rules. The committee is of the view that the complexity, technicality and particularity of the work is determined by the nature and objectives of the works. Merely low cost is not the criterion for any work to be classified as simple or complex.

Decision:

After discussion in detail, the Complaint Redressal Committee (CRC), in the exercise of powers delegated under Rules-31(3) & (5) of SPP Rules, 2010 (Amended 2019) declares the instant complaint dismissed and allows the Procuring Agency/Executive Engineer, Education Works Division Larkano to continue the procurement process as per Rules.
