- 2. The C.R.C meeting was conducted regarding complaint on N.I.T No.XEN(EWD)/A.B/TC/104, dated 21-03-2022 of Education Works Division, Dadu.
- 3. Complainant M/S Muneer Ahmed Memon present in C.R.C meeting stated that he down loaded tender documents and submitted same to Executive Engineer concerned through TCS wherein his offer for 2 works (at S.No:4&5) was lowest than other participants but his bid was not declared successful. He further claimed that the Executive Engineer, Education Works Division Dadu had promised to allot one work to him therefore he signed the attendance sheet.
  - 4. The Chairperson then invited Executive Engineer, Education Works Division, Dadu to share his views.

The Executive Engineer, Education Works Division, Dadu submitted his point of view that M/S Muneer Ahmed Memon, did not participate in tendering process so how can he be awarded the work. He challenged that complainant did not at all submit any bid through TCS which he never received and complainant has just cooked a story with TCS receipt to pressurise and malign him and sabotage the tendering process of this important project of government which is scheduled to be handed over by June this year.

- 5. The complainant was asked to counter the view point of Executive Engineer, produce evidence regarding receipt of his bid complete in all respects to Executive Engineer. However the complainant said that he may take the oath on HOLY QURAN but did not submit any evidence.
  - 6. The committee after hearing both the parties discussed the matter at length and reached the conclusion that: -
  - (i) Since the complainant did not submit any proof regarding receipt of his bid to Executive Engineer, mere producing TCS receipt is not sufficient evidence to prove that the complainant has actually submitted the bid and that too with required bid security etc. Hence the procuring agency can not be blamed to have ignored his bid, hence he could not be treated as "bidder" or "intending bidder" as per rule 2(i)(f) of SPP rules. His complaint against Education Works Division Dadu is therefore dismissed.

(ii) Procurement Agency is therefore allowed to continue procurement process as per rules.
