The Chair welcomed the participants/members and Procurement Committee members briefed that the tender was invited vide NIT No. DD/PDM&I-CELL/CTA&AD/REV/NIT/2021-22/152, dated 12th January, 2022 & opened by Procurement Committee on 09th February, 2022 in the presence of owners/representatives of firms. According to the outcome of bid opening meeting of above referred NIT there were 2no works (Procurement of Furniture & Fixture & Procurement of Machinery & Equipment). Total 8(Eight) firms/companies purchased bidding proposal for Procurement of Furniture & Fixture, however only 7(Seven) bidders participate in the bidding process and total 10 (Ten) firms/companies purchased bidding proposal for Procurement of Machinery & Equipment, however 8(Eight) bidders participate in the bidding process.(Attendance Sheets are attached as Annexure-A). All the bidding documents were opened by procurement committee and rates offered by firms/companies were announced by procurement committee as per SPPRA rules. After evaluation of bids and eligibly criteria checked by procurement committee the result were announced, communicated to bidders and uploaded on SPPRA website (attached as Annexure-B).

However M/s Al-Masroor Construction Co. has submitted a representation to Chairman, Complain Redressel Committee vide letter ref No Nil, dated 07th April, 2022 that the "Procurement Committee has reject our bids" (letter attached as Annexure-C).

The Chairman, CRC raised query about version of bidder from Members of Procurement Committee. The Member of procurement committee explained to CRC that bids were evaluated & announced by procurement committee as per SPPRA Rules, however during the scrutiny of eligibility criteria mentioned in NIT, M/s Masroor Construction & Co were found <u>ineligible</u> due to firms having not three years experience in relevant experience & firms having not completed three procurement in relevant field.

The committee listened to bidder, and after valid justification by procurement committee as per SPPRA Rules and also scrutiny and evaluation of bidder documents by CRC Committee, the bidders was not as per Eligibility and Evaluation Criteria mentioned in NIT. The bidder was satisfied.

Keeping in the view of above referred facts unanimously the Complaints Redressel Committee rejected the application/complain of Al-Masroor Construction Co.
