### Background: -

- 1. The Chief Engineer, Irrigation Kotri Barrage Hyderabad Constituted Complaint Redressal Committee vide his office Notification No. S-151/W-4/CRC/BC/2021-22/1952, dated 22.06.2022.
- The complaint Redressal committee meeting was convened for hearing of grievances / complaints of above cited / mentioned bidders / complainants in connection with the NIT invited by Executive Engineer, Kotri Barrage Division, Jamshoro vide No. SKP/G-66/760, dated 22.06.2022.

- 3. The above named Bidders / complainants, out of which one is appeared namely M/S Shahid Builders in the CRC meeting, whereas, M/S M.B Royal Enterprises and M/S Permanand & Company remain absents.
- 4. The present Bidder namely M/S Shahid Builder has briefed his complaint / grief that the procurement committee did not announce the rates, although Procurement Committee observed all codal formalities as per SPPRA rules.
- 5. The Executive Engineer, Kotri Barrage Division, Jamshoro briefed the Committee regarding the codal formalities adopted in above said NIT as per SPPRA Rule. The Procurement Committee opened the sealed bids in presence of participant bidders and checked for bidding documents whether complete in all respect and accompanied with required documents as mentioned in Notice Inviting Bids, on the basis of that the procurement committee announced qualification / disqualification & rejection of bids. The Procurement Committee announced aloud the rates of all qualified bidders / firms. Total Nos. of items were 429 and announcement of rates of all qualified bidders / firms took a lot of time, most of bidders / firms left the office before completion of announcement process, so also the complainant M/S Shahid Builder whose rates are partially filled (incomplete) which warrants to disqualification.

## Proceeding / Decision: -

The Chairman Complaint Redressal Committee (CRC) and Members after hearing complainant bidder M/S Shahid Builder and Procurement Committee has disqualified thus the complaint is <u>disposed off as the complaint is</u> <u>baseless.</u> Furthermore, the complaint of M/s MB Royal Enterprise did not appear before this Committee, but the Executive Engineer, Kotri Barrage Division, Jamshoro apprise this company is already qualified in result and shall be included in Bid Evaluation Report (BER) and M/s Permanand & Company is <u>disposed off as his complaint is similar to the complaint of M/S Shahid</u> <u>Builder and he did not appear to defend his stance.</u>
