Procuring committee is advised to complete the process of procurement as per Sindh Public Procurement Rules in the based interest of public work.

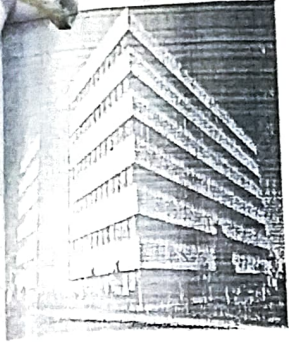
