**MINUTES OF THE COMPLAINT REDRESSAL COMMITTEE (CRC)**  
**HELD ON 12-01-2023 REGARDING COMPLAINT MADE BY**  
**M/S ABDUL HAFEEZ KOLACHI GOVERNMENT CONTRACTOR**

The meeting of Complaint Redressal Committee (CRC) was held on 12-01-2023, in terms of Rule No: 31 of SPPRA Rules 2010 (Amended to date) in order to redress the grievances of M/S. Abdul Hafeez Kolachi, Government Contractor regarding tenders invited for procurement of different work in office of the Executive Engineer Provincial Highway Division Khairpur NIT No: TC/G-55/ 1640 Dated: 28-12-2022

**COMPLAINT REDRESSAL COMMITTEE PROCEEDINGS:**

The Meeting was started with the name of Almighty Allah. The Superintending Engineer Provincial Highway Circle Sukkur / Chairman Complaint Redressal Committee (CRC) welcomed all the participants for attending the Meeting and narrated that the Meeting was conveyed in terms of Rule No: 31 of SPPRA Rules 2010 (Amended to date). The participants were informed that M/S. Abdul Hafeez Kolachi has lodged complaint for redressal of their grievances regarding tenders invited by the Executive Engineer Provincial Highway Division Khairpur vide NIT No: TC/G-55/ 1640 Dated 28-12-2022. The chairman asked the complainant to present their case / version on the instant NIT before the committee.

**VERSION OF THE COMPLAINANT:-**

The Executive Engineer Provincial Highway Division Khairpur has committed the following irregularities:-

- I. Invited tenders by adopting Single Stage Two Envelope Procedure by violating Rule No: 46(1) and 47(1) of SPPRA Rules. The works mentioned in NIT fall under the ambit of Single Stage One Envelope. The Two Envelopes method delays in process.
- II. Funds are not available on the works of the instant NIT.
- III. The Procuring Agency intentionally violated SPPRA Rules and denied the merits and transparency for their own benefit.
- IV. The infirmities / observations raised by PPMS have not been complied.
- V. The conditions of the yearly Audit report is very hard.

**PROCURING AGENCY'S VERSION:-**

Mr. Zain-ul-abdin Morio Executive Engineer Provincial Highway Division Khairpur / Chairman Procurement Committee replied as under:-

- I. The tender were invited by adopting "Single Stage Two Envelope Procedure" as allowed under Rule No: 46(2) of SPPRA Rules 2010 (Amended to date) process will take the some time frame.
- II. M/S. Abdul Hafeez Koalchi (Complainant) has already challenged the "Single-Stage Two Envelope Procedure" in Review Committee of SPPRA held on 27-01-2021 wherein his complaint was dismissed.
- III. The Review Committee has given its decision that Procuring Agency is empowered to choose any method of Procurement under SPPRA Rules. The discretion lies with the Procuring Agency to take decision regarding method of Procurement according to nature of the work, circumstances and needs of the Procuring Agency.
- IV. The Observations raised on PPMS by SPPRA have already been complied by the Procuring Agency.
- V. The conditions of Audit report is a regular condition.

DECISION OF COMPLAINANT REDRESSAL COMMITTEE (CRC):-

After hearing the both parties in depth, going through the relevant rules, grievances of the Complainant and decision given by the Review Committee of SPPRA in the Meeting held on 27-01-2021. It is unanimously decided that tenders are invited according to SPPRA Rules, hence the complaint stand dismissed.


