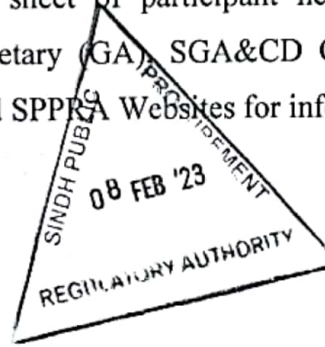

SUBJECT:- MINUTES OF THE MEETING OF THE COMPLAINT REDRESSAL COMMITTEE, FOR THE PURCHASE OF UNIFORM AND LEVIERS.

A meeting of the Complaint Redressal Committee was held on 03.02.2023 at 4.00 p.m., under the Chairmanship of Additional Secretary (GA), regarding complaint of M/s Zain Traders for the procurement of uniform and Leviars and mentioned that the technical evaluation restriction competition have been introduced which are in violation of Rule-44 SPPRA Rules: -

Sr.#	Discriminatory Eligibility Criteria
1.	Eligibility Criteria (c): Financial Turnover: Bidder must have average financial turnover of at least PKR 10.00 Million during the last three financial years
2.	Criteria (d): Last three years audited financial statements are required.

2. The Additional Secretary (GA) Chairman procurement committee mentioned that the procurement Committee consisted of following members :-

1. Mr. Jamsheed Alam Memon, Chairman
2. Mr. Amanullah Bhatti, Procurement Specialist Consultant, Independent Member.
3. Mr. Muhamamd Abid Hussain, AAO, Accountant General Sindh, Karachi.

4. The Procurement committee approved the bidding document and has kept Annual Financial Turnover upto 10 Million for last three years and Last three years audited financial report to ascertain the financial worthiness of the firm which was not available in Tender documents of M/s Zain Traders.

5. The procurement committee also mentioned that technical bids have opened on 10-01-2023 wherein five bids have been received. It is also relevant to mention that two firm's bids were disqualified on the eligibility criteria and three firms qualified. Hence it is evident that reasonable competition has taken place.

6. It is informed that Rule 31 (7) stipulates "Mere fact of lodging of a complaint shall not warrant suspension of the procurement proceedings". Furthermore, with reference to observations raised it is mentioned that the criteria is broad based. The Annual Financial Turnover up to 10 Million for last three years is required so that the bidder must have the financial worthiness to provide the required articles. Besides, requirement of audited statements ensure that the manufacturer, company or the supplier has more credit worthiness and reliability. Most of the organizations fulfill these conditions.

9. The Committee unanimously decided that the complainant M/s Zain Traders could not give evidence to prove his claim whereas the criteria seem to be reasonably competitive and apparently does not restrict competition. With these observations, CRC disposes of the complaint of M/s Zain Traders in terms of Rule 31 of SPPRA rules for procurement of Uniform and Leviers.
