In this connection the complaint received from M/s. Atif Nazar (Pvt.) Ltd. Vide ref: ANPL/KHI/PIU-LGD/RFP066-23 dated: 23rd January, 2023 was discussed in the presence of the representative of M/s. Atif Nazar Pvt. Ltd. which had the observations regarding the following parts of the RFP evaluation. Item wise discussions / decisions are as follows.

Complaint / Grievance: (Principal Electrical Engineer).

#### Discussion:

The committee discussed and reviewed that as per RFP the Principle Electrical Engineer of with Master's Degree required 20 years of experience for full points. Also the Bachelor's degree Engineer required 25 years of experience for full marks (05). After reviewing the documents, the Committee decided that the Electrical Engineer of M/s. Atif Nazar meets the criteria for full marks (05) as per the RFP, having a Bachelor's degree in a relevant field and more than 25 years of experience.

With reference to theletter No.Dir(Admin)/PIU/01-27/2023 dated: 27<sup>th</sup> January, 2023 the meeting of **Complaint Redressal Committee** was held on 31<sup>st</sup> January, 2023 in office of the Special Secretary (LG) / Project Director, PIU, Resettlement of Affectees Project, 1<sup>st</sup> Floor, Annexe building # 5, Tughlaq House, Sindh Secretariate, Karachiwherein the following membersof the CRC attended the meeting: -

The members of the Consultant Selection Committee, Mr. Zain ulAbdin Mirani (Chairman CSC), Mr. Rahat Fahim (Member CSC), and Mr. Muhammad Amir Qureshi (External Member CSC), were summoned to address the criteria mentioned in the RFP. Upon asking, the CSC members emphasized that the criteria (PEC Codes) specified in the RFP are critical to the project and mandatory for a consultant to be eligible for technical evaluation.

## 1. Complaint / Grievance: (M/s. Zeeruk International (Pvt.) Ltd)

Mr. Muhammad Rafae Kamran (Business Development Manager) Representative of M/s. Zeeruk International (Pvt.) (Ltd) stated that they had already applied / submitted their case for the renewal of the PEC Registration on 21<sup>st</sup> July, 2022 and requested for the relevant Project Profile Codes as required in performing the services against the subject project.

#### Discussion:

The Committee reviewed the matter and found that as per the RFP, Project Profile Codes 1206 (Water Transmission lines) and 1231 (Landscaping and Horticulture) are essentially required for the project, and the consultant must possess a valid registration certificate from the Pakistan Engineering Council (PEC) with these codes at the time of bidding. Hence, this is a mandatory condition for being eligible for technical evaluation.

#### **Decision:**

 Based on the above considerations, the Committee decided to endorse the decision of the Consultant Selection Committee.



# Complaint / Grievance: (M/s. National Engineering Services Pakistan (Pvt.) Ltd.)

Mr. Aijaz Ahmed Shaikh, Chief Engineer, Representative of M/s. National Engineering Services Pakistan (Pvt.) Ltd. stated that they had applied for obtaining this code from PEC before submission of the subject proposal. The PEC have provided the service code 0545 (Procurement services) to M/s. National Engineering Services Pakistan (Pvt.) Ltd. on January 25, 2023.

### Discussion:

The Committee discussed the matter and confirmed that as per the RFP, Service Code 0545 is essential for the project, while M/s. National Engineering Services Pakistan (Pvt.) Ltd. obtained the code after the date for bidding. However, it is a mandatory requirement for a consultant to possess a valid registration certificate from the PEC with this code at the time of bidding. Hence, at this stage it cannot be entertained as it will not provide level playing field for others.

#### Decision:

 Based on the above considerations, the Committee decided to endorse the decision of the Consultant Selection Committee.
