This office representative have personally contacted the complaint as well as sent the letter on whatsapp and also dispatched the same through MYS (Pakistan Post). Despite of that the complainant did not attend the CRC Meeting.

COMPLAINT REDRESSAL COMMITTEE PROCEEDINGS

The Meeting started with the name of Almighty Allah. The Superintending Engineer Provincial Highway Circle Sukkur/ Chairman Complaint Redressal Committee (CRC) welcomed all the participants for attending the Meeting and narrated that the Meeting was conveyed in terms of Rule No. 31 of SPPRA Rules and narrated to date). The participants were informed that M/s Al-Fatah 2010 (Amended to date). The participants were informed that M/s Al-Fatah Construction Co, has lodged complaint for redressal of their grievances regarding tenders invited by the Executive Engineer Provincial Highways Division Sukkur vide NIT No. TC/G-55/106 Dated: 20.01.2023.

<u>VERSION OF THE COMPLAINANT MENTION IN HIS COMPLAINT</u>

The Executive Engineer Provincial Highways Division Sukkur has committed the following irregularities, vide his complaint No. AF-248 Dated: 27.02.2023.

On the day of opening the Al-Fatah Construction Co Proprietor Shah Faisal approached the said XEN for dropping Technical and Financial Proposal which was adopted wrongly by the XEN as alleged by him and upon this, the complainer filed the complaint in CRC but complaint was dismissed by showing the agency as absence. He further, alleged that the same is total illegal unlawful act and further blamed that Superintending Engineer is fully supported in illegal act, besides this, in my absence the NIT be cancelled and as it has clearly become of the MISPROCUREMENT from the side of Procuring Agency and order to call fresh NIT observation of SPP Rule 2010.

PROCURING AGENCY'S VERSION

Mr. Javed Ahmed Kalhoro, Executive Engineer Provincial Highways Division Sukkur /Chairman Procurement Committee replied as under:

- In this connection after reading the complaint the complainer who has already
 made the complaint to the CRC Chairman Committee and your kind honour
 already dismissed his complaint. Now he has made complaint on the same NIT
 because of this, there is wastage of time & sabotage of the smooth work of the
 Government.
- 2. The aim of complainer is that he wants to take benefits illegally, hence unnecessary complaint is being made by fabricating cock & bull story whereas tendering process is being carried out as per SPPRA rules of (90) Ninety days which is mentioned in the said NIT, after the scrutiny of Technical Tendering Process is completed then financial date will be announced accordingly.
- 3. In view of the above facts & figure, it is requested that the complainant is habitual complainer he is only wasting the time but nothing, as such he may be taken appropriate action or as deemed fit to stop such situation so that no any agency dare to create problems in Tendering Evaluation Process.

DECISION OF COMPLAINANT REDRESSAL COMMITTEE (CRC)

The complainant was sent notice for attending the Complaint Redressal Committee Meeting (CRC) i.e on 14.02.2023 vide this office letter No. BB(i)/125481 Dated: 1002,2023, but inspite of that he remained absent without any intimation. The Complaint Redressal Committee is of the unanimous view that there is no any illegality, irregularity or any malpractice on the part of the Procuring Committee, the Complaint has been made without any justification and hence complaint do not merit any consideration, which stand dismissed.

The meeting ended with a vote of thanks from the Chair.
