The participants were informed that M/S. Al-Fatah Construction Company has lodged complaint for redressal of their grievances regarding tenders invited by the Executive Engineer Provincial Highway Division Khairpur vide NIT No: TC/G-55/ 1640 Dated 28-12-2022. The chairman asked the complainant to present their case / version on the instant NIT before the committee.

## VERSION OF THE COMPLAINANT MENTIONED IN THE COMPLAINT:-

The Executive Engineer Provincial Highway Division Khairpur has committed the following irregularities:-

- Complaint under Rule No: 31 of of SPP Rules 2010, against Procuring Agency, (The Executive Engineer Provincial Highway Division Khairpur) as the Executive Engineer has i. misused his Executive Powers by awarding the works on highest rates to his chosen Contractors & not issuing the qualification or Dis-Qualification letter not conducting the opening of (Financial Proposal) in Below mentioned NIT violated SPP Rules 2010.
- That the procuring agency has imposed difficult and discriminatory conditions in the subject NIT just to avoid the wide competition and to make illegal settlements. ii.
- I participated on work No. 5 as lowest bid iii.
- So NIT may kindly be canceled and recall iv.

### PROCURING AGENCY'S VERSION:-

Mr. Zain-ul-abdin Morio Executive Engineer Provincial Highway Division Khairpur / Chairman Procurement Committee replied as under:-

- 1) The Bidding process was completed in a transparent manner and works were awarded to the successful bidders in terms & conditions of NIT and bidding documents.
- 2) The complaint was well informed about rejection of Bid as the Bid of Complainant was
- 3) On the behalf of the Contractor his representative appeared before Procuring Committee
- 3) According to terms & conditions mentioned in NIT Condition No. ix contractor has to submit Annual Income Tax Return of last Three years.
- 4) According to illegibility / mandatory criteria (ii) that at least 03 works having same specifications and nature having equal or more cost <u>OR</u> quantum (in terms of quantities) completed during past three years duly supported with completion certificate, certified copies detailed working estimate and SPPRA ID's showing Bid evaluation report. But Contractor failed to provide work order of same nature / amount.
- 5) According to condition No. xi each page of technical proposal must be numbered and attested by the owner of firm of company alongwith stamp, but contractor did not signed
- 6) According to illegibility / mandatory criteria (v) that Annual audited reports of last three years from (ICAP) registered audit firm. Audit report issued other than (ICAP) registered audit firm will not be accepted. But contractor failed to provide audit report of three years.
