However, the Chairman and Members of CRC asked Executive Engineer Rohri Division Kandiaro who is Chairman Procurement Committee to explain the position in the light of allegations leveled by the complainant.

A meeting of Complaint Redressal Committee (CRC) as per SPPRA Rule 31(3) regarding subjected complaint was held on **19.05.2023 @ 03:00 P.M** at Rohri Canal Circle Office Hyderabad for redressal of grievances of the complainant. The meeting was chaired by the Superintending Engineer Rohri Canal Circle Hyderabad Chairman (CRC) and participated by Mr. Irfan Ahmed Memon Civil Engineer (Independent Professional) Member (CRC), Divisional Accounts Officer Rohri Division Kandiaro Member (CRC) and Executive Engineer Rohri Division Kandiaro (Chairman Procurement Committee), **whereas the complainant M/s Qalandar Bux Abro & Co: Government Contractor remained absent.** Although the complainant was informed to appear before CRC meeting on above date and time vide this office letter No: AC / G – 55 / 2213 dated. 17.05.2023 sent through UMS, but despite that he did not attend meeting. However, the Chairman and Members of CRC asked Executive Engineer Rohri Division Kandiaro who is Chairman Procurement Committee to explain the position in the light of allegations leveled by the complainant.

**ALLEGATIONS OF COMPLAINANT**

The complainant has alleged that while opening of “Technical Proposal” only Bid Security was checked and also expressed the fear that the tenders would be manipulated to extend favour to the contractor of their own choice and contractor would be awarded at higher rate. The complainant has further requested for cancellation of NIT and conduct enquiry to fix the responsibility regarding mis-use of authority, misappropriation of funds etc:

**In response to allegations leveled by the complainant in application, the Executive Engineer Rohri Division Kandiaro (Procuring Agency) replied as under:-**

1/- That, as per SPPRA-2010 Rule 47 (2) “Single stage two envelope bidding procedure was used for goods 3[works] and services where the bids were evaluated on technical and financial grounds and price was taken into account after technical evaluation”. This N.I.T consists of One No: work i.e. Construction of Stone Pitching and Strengthening Earth work along S.M Bund from Mile 38/2 to 40/0, 42/0 to 42/5 & Stone Apron 41/5 to 42/5 (Dad Wah) amounting to Rs. 217.228 million.



2/- As per SPPRA Rule 46 Para-2 (c) “initially only envelope marked **Technical Proposal**” was opened as per schedule “**Technical Proposals / Bids**” dropped by the participant contractors were opened 18.04.2023, whereas, the sealed financial proposal were kept in custody as per Rule 46 Para-2(d) to be opened of only technically qualified contractors / firms as per Rule 46 Para-2 (g).

3/- As per Rule 46 Para-2(d) “envelope marked as **financial proposal retained in the custody of the procuring agency without being opened;**” hence financial proposals were kept in custody as per SPPRA Rules.

4/- As per version of Executive Engineer the procuring agency has strictly followed SPPRA Rules.


5/- Subsequently as per Rule 46(2)(e) the “**Technical Proposals**” of all participant contractors were evaluated including complainant and found that the “**Registration Certificate of Pakistan Engineering Council**” was not attached with Technical Proposal, submitted by the complainant hence complainant was technically disqualified and Financial Proposal was not opened on the date of opening of Financial Proposal. In addition to above he further stated that no act of favoritism, manipulation, mis-use of authority was conducted but entire process of procurement was completed according to SPPRA Rule.

### **Conclusion of the Complaint Redressal Committee (CRC)**


From the perusal of the facts explained by the Executive Engineer Rohri Division Kandiaro (Procuring Agency) as well as scrutinizing the relevant record, it was observed that on one hand M/s Qalandar Bux Abro (complainant) remained absent during CRC meeting to prove his allegations mentioned in the complaint and on other hand no any authentic document was attached with complaint.

### **Decision of Complaint Redressal Committee (CRC)**

After going through the facts explained by the Executive Engineer Rohri Division Kandiaro (Chairman Procurement Committee) and due to absence of complainant the Complaint Redressal Committee (CRC) unanimously decided to dismiss the complaint and announces its decision according to RuleNo. 31(5) of SPPRA Rule 2010 (Amended 2019).




