

Complaint Redressal Committee Proceedings

The meeting was started with name of Almighty Allah. The Project Manager, Project Implementation Unit, Hyderabad-Mirpurkhas Dual Carriageway Project, Hyderabad / Chairman Complaint Redressal Committee welcomed all the participants for attending the meeting and narrated that the meeting was conveyed in terms of Rule No: 31 of Sindh Public Procurement Regulatory Authority Rules-2010 (Amended-up to date). He informed that above mentioned applicants have lodged complaint for redressal of their grievance regarding Tenders invited for procurement of different works in office of the Executive Engineer, Provincial Highways Division, Naushahero Feroze, vide NO: TC/G-55/388 Dated 09-03-2023

The Chairman Complaint Redressal Committee informed all the members of complaint Redressal Committee that withdrawal applications are received from the complainant's M/S Sajid Builder & M/S Asif Ali Chandio, Government Contractor today wherein they have withdrawn from their complaints.

Complainant M/S Muzaffar Hussain & Brothers has not attended the meeting personally but another person namely Mr. Abdul Karim Kolachi tried to represent the complainant without authority on Stamp Paper in order to ensure his authentic representation. Hence, he was disallowed to represent the complainant.

In addition to above, M/S Muzaffar Hussain & Brothers (Complainant) has alleged that neither one member of Procurement Committee was available on the date of opening nor Tender Box was placed for dropping. Further the complainant has alleged that Executive Engineer did not issue letter to him nor he conducted any financial opening.

In this connection, Executive Engineer, Provincial Highways Division, Naushahero was requested to explain his position in the light of allegations levelled by the complainant.

Version of Executive Engineer


The Executive Engineer, Provincial Highways Division, Naushahero Feroze stated that the bids were opened on 05-04-2023 @ 12:00 P.M. by the Procurement Committee in presence of the contractors and their attendance was also obtained on the attendance sheet. The tender box was available and sealed bids were dropped by the contractor in the tender box. Whereas the complainant had submitted his envelop which was found completely blank and neither he attended his office on the date of opening of the bids nor there is any truth in each allegation. Entire process of procurement was completed according to SPPRA Rules-2010 (Amended upto date).


Decision of Complaint Redressal Committee


The Complaint Redressal Committee accepted the withdrawal application submitted by the complainants. Regarding M/S Muzaffar Hussain & Brothers, Government Contractor, whereas representation of Mr. Abdul Kareem Kolachi was not acceptable without any authentic authority. The complainant was failed to submit any solid documentary proof regarding his allegation. Besides this the allegations of the complainant were itself controversial. On one hand he had

submitted the bid through courier service and on other hand he has alleged that neither one member of procurement committee was present nor tender box was available for dropping the bids, whereas, member of the procurement committee was available, signed attendance sheets and bids were also opened in presence of the contractor who were present. Apart from this, the complainant has alleged that he was not issued letter by the Executive Engineer regarding opening of Financial Bids, which reveals that he is not aware about the procurement process. The letters regarding opening of Financial Bids are issued to the contractor in case of Single Stage Two Envelope procedure, whereas the method of the NIT was Single Stage Single Envelope. Hence the complaint was dismissed.

The meeting ended with the vote of thanks to and from the chair.
