The Executive Engineer, T.M.Khan Drainage Division, T.M.Khan (Procurement Agency) has informed before the Complaint Redressal Committee that above said Government Contractor has furnished their bidding documents through Mail and attended the process of Technical Opening on 19.04.2023 and submitted their Bank Guarantee. But he did not attend and their representative process of Financial Opening on 28.04.2023. During the course of Financial opening his bidding documents found blank and not quoted any bid (copies of the same are enclosed). The Procurement Committee has rejected their Bidding documents at the time of opening of Financial Bid.


DECISION.





