

PROCEEDINGS OF CRC:

The Chairman Complaint Redressal Committee welcomed and informed all the participants regarding the complaint/Appeal received from M/s Kolachee

International (Pvt) Ltd regarding their grievance against the decision of Procurement committee.

COMPLAINANT'S GRIEVANCES:

The M/s Kolachee International (Pvt) Ltd stated that as per the BER of Procurement committee their firm was disqualified on the basis that their bid was not submitted on standard bidding documents. They further stated that they had submitted all the required / relevant documents along with all forms (signed & stamped on letterhead) as mentioned in the NIT and they fulfill all the evaluation criteria as mentioned in Bid data sheet. Therefore, their bid should be considered as qualified. Further they stated that they had submitted the lowest bid the award was recommended to the second lowest bidder i.e. M/s KSF Trizone.

PROCUREMENT COMMITTEE RESPONSE:

The Procurement Committee stated that the method of said NIT was "Single stage, one Envelope", and on the date of opening of tender i.e. 08-05-2023, the representative of M/s Kolachee International (Pvt) Ltd. was present in the committee room with all other bidders. The financial proposals of all the bidders were announced one by one loudly in the presence of all bidders. It is also pertinent to mention here that the Chairman Procurement Committee also announced that the lowest quote / rate does not mean that the bidder who offered lowest bid is successful until and unless the procurement Committee completes the detailed scrutiny of bidding documents along with other required documents submitted by the bidders in the light of the criteria as mentioned in The Sindh Public Procurement Rules 2010 (amended up to date). During the course of scrutiny, it was observed that M/s Kolachee International (Pvt) Ltd did not submit the bid on the standard bidding documents as laid down in Rule 24 (2) of the Sindh Public Procurement Rules 2010 (amended up to date) which clearly states as Follows:

Submission of Bids: "The Bidders may submit bids on the bidding documents issued by the procuring agency or downloaded from the Authority's website along with tender fee if any by mail or by hand."

In addition to this, according to the SPP Rules 2010 ["Bidding Documents" means the documents notified by the Authority for preparation of bids in uniform manner;] furthermore clause 5.1 of ITB also defines the composition of Bidding documents which states as:

The bidding documents include:

- (a) Instructions to Bidders (ITB)
- (b) Bid Data Sheet
- (c) General Conditions of Contract (GCC)
- (d) Special Conditions of Contract (SCC)
- (e) Schedule of Requirements
- (f) Technical Specifications
- (g) Bid Form, Price Schedules and Miscellaneous Forms
- (h) Bid Security Form
- (i) Contract Form
- (j) Performance Security Form
- (k) Manufacturer's Authorization Form

In response to the grievance of the complainant that they had submitted the lowest bid, the procurement committee responded that there is difference between Lowest submitted price and Lowest evaluated bid. According to the Rule 49 of the SPP Rules 2010:

Award of Contract: The bidder with the most advantageous bid, but not necessarily the lowest submitted price, shall be awarded the procurement contract, within the original or extended period of bid validity.

The Procurement committee further stated that, the in the light of Rule 24 (2), of the SPP Rules 2010 and the clause 5.1 of the ITB of the bidding documents the bid of the complainant was not considered and not recommended for the award.

CRC Decision:

The Complaint Redressal committee, after hearing both the sides and after examining all the documents in the presence of all participants, decided that that non-placement of original bidding documents in technical proposal is "not enough ground to disqualify" as the documents submitted by the complainant were sufficient / fulfilling all the conditions of the NIT and were adhering to the terms and condition of the bidding process, therefore the CRC unanimously decided to declare M/s Kolachee International (Pvt) Ltd as Lowest qualified bidder.

The decision was announced by the Chairman during the CRC meeting in presence of complainant M/s Kolachee International.

The meeting ended with vote of thanks to and from the Chair.
