**MINUTES OF THE MEETING OF REDRESSAL OF GRIEVANCES & SETTLEMENT OF
DISPUTES COMMITTEE UNDER THE CHAIRMANSHIP OF ADDITIONAL INSPECTOR
GENERAL OF POLICE.**

The Redressal of Grievances & Settlement of Disputes Committee constituted against Procurement of SMS FACILITY & INITIALIZATION in DLS for the financial year 2022-23, vide Order No.G-I/934/2023/Karachi, Dated:13.03.2023, in-accordance to the Rule 31 of SPP Rules, 2010 (Amended-2019)

2/- The Committee meeting was held on 19.05.2023, in the office of the Addl: IGP/CTD Sindh, Karachi the following officers attended the meeting:-

1. Imran Yaqoob Minhas, PSP, Addl.IGP Estt. Sindh. (Chairman)
2. Aftab Ahmed, Addl. Accounts Officer,AG Sindh. (Member)
3. Muneeb Soomro, SO Budget, Home Deptt. Govt. of Sindh (Member)

3/- The bidder M/S CM PAK Ltd, filed their grievances against the rejection of their bid. The representative of said firm was also present in the meeting and was given opportunity to explain about their grievances before the committee. He was heard in person and in detail. The representative of the firms raised the following points:-

- i) The evaluation Criteria points number 2 ("No. Of Similar nature contracts/Projects") was not recorded properly.
- ii) The evolution Criteria points number 3 ("Financial Value of Similar nature contracts / Projects in the last five (05) years").
- iii) We provided the names of our costumers due to non-disclosure agreements (NDA) signed with them, instead of submitting Pos / Contracts / Contract agreements evidence.
- iv) The project was awarded M/S JAZZ, Despite our offering a significantly low price of Rs.1.72 per SMS compared to their offer approximately Rs.2.25 per SMS this difference in prices represents a potential loss of approximately of Rs.573,600 to the Department.

4/- The Grievance Committee discussed the matter thoroughly & checked the relevant record specifically Bid Document, Technical Evaluation Report, Bidder Qualification Report, Relevant Experience & Client List (NDA Signed)in-respect of the unsuccessful bidder, hence observed that:-

- i) The Bidder failed to provide Purchase Orders/Work Orders for the technical evaluation which caused him failure in:
 - a) Section 2: Financial Capability- Financial value of Similar Nature Projects in last (05) years: 00
 - b) Section 3: Relevant Experience - No of Similar Nature Contracts/Projects: 00
 - c) Obtained 30/50 Marks, hence disqualified.
 - d. Qualifying Marks: 35.
- ii) The name list of Customers instead of Purchase Orders/Work Orders required under technical evaluation to evaluate the expertise and financial capability of the bidder does not fulfill the requirement has cannot be considered.


