## DECISION.

It is noticed that the above named complainant did not attend the Complaint Redressal Committee meeting held on 26.07.2023 at 02.00 p.m. The Executive Engineer, Thatta Drainage Division, Thatta (Procurement Agency) has clarified and proved his evidence that above said complainant has not participated in the Bid Opening Meeting on 19.07.2023 and did not pay the Tender Fee as well as not submitted Call Deposit due to which Procurement Agency rejected their bid as per SPPRA Rules. The committee also scrutinized bidding processing relevant documents and satisfied the Bidding process adopted by the Procurement Agency.

The committee decided that the complaint made to sabotage of the procurement process for their hidden personal gains and interference in the Government works as per SPPRA Rules, the complaint is hereby filed.
