The CRC meeting held on 26.07.2023 at 03.00 P.M under the following Complaint Redressal Committee to scrutinize the complaint / application made by M/s Din Muhammad Enterprises Builders M/s Abra Construction Company and M/s Dilawar Khan and Brothers, Government Contractors.

All the Committee and Procurement Agency attended the CRC meeting on 26.07.2023. But the complainant M/s Din Muhammad Enterprises Builders, M/s Abra Construction Company Government Contractor and neither attended neither the CRC meeting nor his representative on behalf of them.


M/s Dilawar Khan & Brothers, Government Contractor has attended the meeting discussed about their grievances.

**DECISION.**


It is noticed that the above named complainants M/s Din Muhammad Enterprises Builders and M/s Abra Construction Company did not attend the Complaint Redressal Committee meeting held on 26.07.2023 at 03.00 p.m. The committee also scrutinized bidding processing relevant documents and satisfied the Bidding process adopted by the Procurement Agency.

In response the grievances stated by the M/s Dilawar Khan and Brothers Government Contractor, the Executive Engineer, Sujawal Drainage Division, Sujawal (Procurement Agency) has informed before the CRC that M/s Dilawar Khan and Brothers has submitted conditional bids, M/s Dilawar Khan and Brothers quoted only three (03) Nos items and all the remaining items were found blanks which has already been mentioned / published in NIT / News papers that no conditional bids shall be accepted also Call deposit required as accumulating the Bid Security 05% of total estimated cost Rs: 62.400 Million which comes out amounting to Rs: 03.120 Million but complainant submitted Call deposit quite meager amount of Rs: 01.250 Million. Hence the Procurement agency rejected the bids due to non fulfilling the Eligibility criteria.

The committee decided that the complaint made to sabotage of the procurement process for their hidden personal gains and interference in the Government works as per SPPRA Rules, the complaint is hereby filed.


