Meeting of Complaint Redressal Committee (CRC) was held on 05-09-2023 at 02:30 (noon) in the office of the Superintending Engineer, Provincial Highways Circle Larkano in accordance with the SPPRA Rule 31 of Sindh Public Procurement Rules-2010 (Amended up-to-date) to contemplate into complaints made by the following Firms / Contractors versus the Executive Engineer, Provincial Highways Division Larkano / Procuring Agency against the above subjected NIT.

Accordingly all (07) No. of above complainants as well as Executive Engineer concerned / procuring agency have been issued letter vide No. SE(PHWC)BB/1733 dated 30-08-2023 and No. SE(PHWC)BB/1738 dated 31-08-2023 has been requested to attend the meeting of Complaint Redressal Committee on 05-09-2023, so as to ascertain the factual position / matter and redress the grievances.

**Proceedings:-**

Out of (07) No. of complainants namely M/S Muazaffar Hussain & Brothers Sr. No.2, M/s Muhib Ali Sadhaya Sr. No. 03, M/s Furqan Hyder & Co. Sr. No. 06, M/s Al-Fatah Construction Company Sr. No. 07 withdrawn their complaints on their letter head before the Committee being satisfied (copy attached annexure-A).

Sr. No. 01 M/s Saeed Ahmed Jatoi & Co. did not attend the CRC Meeting.


While going through the contents of complaints made by M/S Engr. Riaz Hussain Langah & Co., & M/s Ali Hassan Junejo, Government Contractors they were of view that the Executive Engineer / Procuring Agency Provincial Highways Division Larkano had given undue advantage to the selected firms through manipulative procedure and had award the development works to them on full rate upto estimated cost.


In response to above the Executive Engineer / Procuring Agency has submitted vide letter No.TC/G-55/2140, dated 30-08-2023 that M/S Engr. Riaz Hussain Langah take away his broacher forcedly before the scrutiny of record therefore, the Executive Engineer / Procuring Agency Provincial Highways Division Larkano is not in a position to explain his position. (copy attached annexure-B).

In response to complaint of M/s Ali Hassan Junejo, the Executive Engineer / Procuring Agency Provincial Highways Division Larkano has submitted that the above named complainant is dis-qualified in Technical Evaluation vide letter No.TC/G-55/1986, dated 21-08-2023 (copy attached annexure-C). Which was communicated to him.

**Conclusion:-**

In the light of above discussed matter, The Committee decided to file the instant complaints which do not carry the weight-age in this regard.
