MINUTES OF MEETING OF CRC HELD ON 06.09.2023 UNDER THE CHAIRMANSHIP OF CHIEF ENGINEER (DEV.) PUBLIC HEALTH ENGINEERING DEPARTMENT SUKKUR IN RESPECT OF COMPLAINT MADE BY VARIOUS CONTRACTORS AGAINST NIT NO.AB / TC /750 DATED: 06.06.2023, PHE DIVISION KAMBER SHAHDADKOT @ KAMBER.

The Meeting of CRC of Public Health Engineering Department Sukkur was held on 06.09.2023 at 2:00 PM in the office of Chief Engineer (Dev.) Public Health Engineering Department Sukkur to discuss and address the complaints in respect of NIT NO.AB /TC /750 dated: 06.06.2023, filed by various contractors. The meeting was attended by following:
