Meeting started with the recitation of Holy Quran.

Chairman/ Additional Secretary, (Tech) welcomed the participants/ members of the committee and the bidders/ representatives of the bidders and opened the discussion as per agenda.

The representatives of Mughal Traders, Karachi informed the forum that their firm has applied bid for the ADP Scheme # 01 "Establishment of Date Palm Research Institute, Khairpur" and ADP Scheme # 03 "Establishment of Horticulture Research Institute, Sukkur" and completed all codal formalities as desired by procuring agency but despite that they were disqualified by the Procuring Agency.

The representative of Salah Brothers, Khairpur informed the forum that their firm has applied bid for the ADP Scheme # 03 **Establishment of Horticulture Research Institute, Sukkur**" and always submit the bid security in technical proposal but they were also found disqualified.

The representative of the Procuring Agency apprised the forum that many deficiencies were found in the technical proposals of Mughal traders, Karachi and Salah Brothers, Khairpur including no signed back of bidding documents, missing of pages from bidding documents, no bid security etc which looks against the Rule No. 43(1) of SPPRA Rules 2010 (Amended 2019) and Rule No. 46(2) of SPPRA Rules 2010 (Amended 2019). Procuring Agency has already informed both the firms about these deficiencies with the request to consider and clarify the bid as per Rule No. 43(1) & 46(2) of SPPRA 2010 (Amended 2019) within three working days; otherwise their bid may not be considered as responsive.

Mr. Ghulam Mustafa Abro, Member CRC, also shared his views regarding complaint of Mughal Traders, Karachi and Salah Brothers, Khairpur and suggest them to must consider the bid as per SPPRA Rules 2010 (Amended 2019) and to fulfill all requirements as per SPPRA rules for future transparency.

The representatives of both firms admit their mistakes/ weakness and withdrawn their case in written.

The Chair therefore closed the matter after appreciating the cooperation of firms and recommended that the Sponsoring Agency to proceed with the contract implementation process.

Meeting was concluded with the vote of thanks.
