**MINUTES OF COMPLAINT REDRESSAL COMMITTEE (CRC) MEETING**

A meeting of Complaint Redressal Committee (CRC) was held on 25-09-2023 at 2:00 PM in connection with complaints made by the following contractors.

- (1) M S Din Muhammad Enterprises Builders
- (2) M S Diamond Construction Company
- (3) M S Asif Raza Contractor

The meeting was started with the name of Almighty Allah. The chair briefed the members regarding back ground and allegation leveled by the complainants. During meeting M/S Din Muhammad Enterprises Builders Government contractors (complainant) attended the meeting, whereas, other 02 complainants remained absent.

The chair asked the Executive Engineer, Southern Dadu Division to explain the position in respect of the allegation leveled by the complainants particularly M/S Din Muhammad Enterprises Builders who was present in the meeting.

**Version of the Executive Engineer.**

The Executive Engineer, Southern Dadu Division stated that bids were opened by the procurement committee in presence of the contractors or their authorized representatives on 01-08-2023. During opening of the sealed envelopes, bid scrutiny of M/S Din Muhammad Enterprises Builders was not attached with the bids and the same was informed to the contractor on the occasion, but the contractor failed to produce original copy of Bid security.


M/S Diamond Construction Company was also failed to submit bid security along with bid, hence without bid security the bid was not considerable, whereas M/S Asif Raza Government Contractor quoted the rates against item No. 1 to 226 and the remaining items were left by him blank, the rates quoted by him were mentioned in the bid Evaluation Report and the same were hoisted on SPPRA Website.


The chair asked to M/S Din Muhammad Enterprises Builders to explain his position regarding bid security and produce copy of the same if available with him, but he replied that he had not brought with him.


**Decision of the Committee.**






