UNDER THE CHAIRMANSHIP OF SECRETARY LIVESTOCK AND FISHERIES  
DEPARTMENT HELD ON 22-11-2021.

A meeting of complaint Redressal Committee was held under the chairmanship of Secretary Livestock & Fisheries Department to discuss the complaint filed by M/S Iftakhar Hussain Marketing Services against the tender No. DAB/AC/Tender/2021-22/1/INK/KEY NO. 3199/2021 Purchase of Liquid Nitrogen Gas (LNG). The representative of Account General Office did not attend the meeting.

2. The Secretary Livestock & Fisheries Department, Chairman Complaint Redressal Committee welcomed the participants including complainant Mr. Iftakhar Hussain Leghari (CEO) M/S Iftakhar Hussain Marketing Services, and informed him that CRC be conducted in complain on specific format supported with proofs on which the firm aggrieved, the compliant was informed that there are some flaws in complain even than CRC was convened.

3. The complainant informed the forum that his firm has been disqualified for two reason i.e. short in liquid assets and no relevant experience, whereas they provide liquid assets which was more than the required limits. In relevant experience they supplied the gas to Health Department of which proofs were given in bidding document.

4. The chair asked the complainant whether they have supplied Liquid Nitrogen Gas to any Department in the past. He replied "*that he has experience of supplying Oxygen Gas but not Liquid Nitrogen Gas specifically*".

5. Dr. Abdul Qadir Junejo, as Independent professional member stated that Liquid Nitrogen Gas is perishable item having temperature of  $-196^{\circ}\text{C}$  which needs to be transported in specific conditions and containers. It is quiet hard to handle hence a properly experienced firm can be entertained.

6. The chair then, invited chairman procurement committee to share his views on the same. He informed that as per tender document we required liquid assets 0.5 time of quoted bid. The firm provided bank statements. We have one way to verify the same is to write letter to concerned bank which we have done vide letter NO. DAB / AC/ 2873 dated 11-10-2021. In response of the same concerned bank informed that the "*Account under question is edited and is not genuine whereby Account title and few of the transactions are edited and are not factual*". Whereas 2 more bank statements of other banks were supported with bidding documents which were of 2018-19 could not considered as liquid assets because outdated. Secondly the firm has not provided any documentary proofs of relevant experience.


In view of above complaint Redressal Committee unanimously decided that:

i. Bank statement of Soneri Bank is faulty as per written statement of concerned bank and other two statements could not be accepted being outdated.

ii. Relevant experience is important especially in case of Liquid Nitrogen Gas which complainer also admitted that he has no past experience to supply Liquid Nitrogen Gas

iii. The Complaint was not found to be on merit hence it was decided to be rejected.
