MINUTES OF COMPLAINT REDRESSAL COMMITTEE.

Complaint Redressal Committee was arranged in response to complaints against NIT No.TC/812 dated 18-11-2019 for Works of Public Health Engg: Division Tando Muhammad Khan. The NIT was hoisted on SPPRA Website & as well as published in news papers. Complainants M/s. Ghulam Murtaza Enterprises & M/s. Muhammad Hanif Gandro approached Chief Engineer PIHE who is Chairman Complaint Redressal Committee. CRC meeting was called vide letter GM/PHED/CRC/2494 dated 31-12-2019 & No.GM/PHED/CRC/05 dated 02-01-2020 were re-scheduled through No. GM/PHED/CRC/38 dated 06-01-2020 scheduled on 13-01-2020 at 02.30 pm. District Accounts Officer Tando Muhammad Khan did not attend the meeting.

M/s. Ghulam Murtaza Enterprises & M/s. Muhammad Hanif Gandro made the complaint against procurement process carried out in PHE Division Tando Muhammad Khan.

During meeting only one bidder namely M/s. Muhammad Hanif Gandro attended the meeting. On quarry from chair, contractor told that we were only 5 minutes late then the scheduled time of 12.00 noon due to vehicle tyre burst on way from Thatta to Tando Muhammad Khan. On quarry from chair Mr. Abudl Latif Jarwar Chairman Procurement Committee explained that tender box was scaled at 12.00 noon as per given time of NIT and published in news papers, where as both contractors came 45 minutes late when tender box was scaled. However he intimated that opening process was carried out as per SPPRA Rules.

After detailed deliberation complaint of aggrieved bidders were rejected as same were not based on solid evidence which may be considered as violation of SPPRA Rules..

Meeting ended with vote of thanks from and to the Chair.
