it is to inform that in compliance of SPP Rule No.31 being Chairman of CRC a meeting of the committee was held on 28.02.2020 in the office of the undersigned (list of participants attached as Annexure-A) on the subject matter.

After detailed discussion, it was revealed that NIT No.TC/G-55/NIB/32 dated 24.01.2020 was scheduled to be opened on 19.02.2020 but as per version of Executive Engineer Sujawal Drainage Division, the received / dropped tenders were not opened due to absence of 01 member of Procurement Committee and date was extended to 06.03.2020, but the corrigendum was not uploaded on SPPRA's or Irrigation Department's website nor it was published in any National Daily till today.

After hearing the complainants (Contractors) and the Procurement Agency, the undersigned is of the view that the Procurement Agency has failed to follow the SPP Rules by not hoisting the corrigendum in this regard on SPPRA and Department's website. Also so far the same has not been advertised on any National Daily.

In this regard, the relevant SPP Regulation No.4.10(i) of SPP Rule-22 says:-

4.10 Extension of Dead line / Time Period for submission of bids (Rule-22).

"Procuring agency may extend the dead line for submission of bids, as per conditions mentioned in rule22.

> Provided that advertisement of such extension in time shall be done in a manner similar to the original advertisement, in which case all rights and obligations of the procuring agency and bidders previously subject to the original dead line will thereafter be subject to the dead line extended. On Jing

In case, corrigendum or addendum or addendum is issued, following points be taken into consideration:-

• (i) Notice of corrigendum or addendum is issued prior to expiry date of submission of bids or at least published within 3 days of expiry date / opening date and hoisting on the same date".

Therefore, the subject procurement bearing NIT No.TC/G-55/NIB/32 dated 24.01.2020 may be cancelled and tenders be called afresh.
